DBE Policy

WisDOT's Disadvantaged Business Enterprise (DBE) Program is embodied in the Code of Federal Regulations 49 CFR part 26. The U.S. Congress established the DBE program in 1982 to ensure nondiscrimination in the award and administration of DOT-assisted contracts, help remove barriers to the participation of underrepresented firms in DOT-assisted contracts, and assist the development of firms to compete successfully in the marketplace outside of the DBE program.

The program goal is to increase participation of firms owned by disadvantaged individuals in all federal aid and state transportation facility contracts.

WisDOT will not discriminate on the basis of race, color, national origin, or gender in the award and performance of any USDOT assisted contracts in the administration of its DBE program or requirements 49 CFR part 26.



WHO CAN BE A DBE?

A small for profit business that is at least 51% owned and controlled by socially and economocally disadvantaged individual(s).

- Asian-Indian Americans
- Asian-Pacific Americans
- Black Americans
- Hispanic Americans
- Native Americans
- Women
- Any individual deemed as socially disadvantaged resulting from circumstances beyond their control per 49 CFR part 26 appendix E.

ELIGIBILITY CRITERIA

Average Annual Gross Receipts of the business are less than \$30.72M (effective 5/9/2024)

Applicant must prove:

- 51% Ownership of Business
- Operational and Managerial Control
- Personal Net Worth is less than \$2.047M (effective 5/9/2024)
- Technical Competence in Work Area
- Firm is independent of other businesses

DOCUMENTS REQUIRED*

- Uniform Certification Program (UCP) Application
 - * Refer to the Supporting Documentation Checklist in the Certification Application
- Personal Net Worth Statement
- Requested Work/Geographic Area Summary
- Contractor Statement of Experience
- Three (3) years of tax returns
- Go to the DBE eligibility web page for forms

DBE Certification

- 2. Send the completed UCP application with supporting documents to <u>DBE_Alert@dot.wi.gov</u> with subject line: Certification Application.
- **3.** Certification Analyst completes the following steps:
 - **a.** conducts a preliminary review of application submission,
 - **b.** contacts applicant to schedule an onsite review,
 - c. conducts the onsite visit using the WI UCP DBE Onsite Review Form
 - **d.** reviews all documents submitted to evaluate whether the firm meets the burden of proof for a certification decision.
 - **e.** sends a letter of approval or denial listing the decision per the federal regulations.
- 4. Approved firms are published in the WI UCP DBE Directory which primes are required to use for contracts with assigned DBE goals.
