Purpose

The purpose of the US 2 public involvement is to:

- Present information regarding the current condition and needs of the bridges.
- Provide information on the proposed improvements to the bridges.
- Obtain your input and answer your questions.

Project Information

We are proposing to address the deteriorated bridge deck and expansion joint of the eastbound bridge (B-26-0008) and the deteriorated compression joint on the Wisconsin side of the westbound bridge (B-26-0007) along US 2.

Proposed improvements include:

Eastbound Bridge B-26-0008:

- Overlay the deteriorated bridge deck
- Replace concrete approach slabs
- Replace deteriorated expansion joint
- · Replace guardrail on the Michigan side of the Montreal River

Westbound Bridge B-26-0007:

- Repair the compression joint on the west side of the bridge
- Replace the concrete approach slabs on the west side of the bridge

The approximate cost of the proposed construction improvements is \$750,000.

Proposed traffic impacts

Construction is currently scheduled for the summer of 2025.

During construction, traffic would be maintained on the bridges by completing the work half at a time. Traffic would be reduced to one lane and shifted to one side of the bridges while work is completed on the other side of the bridges.

Real estate

No real estate is anticipated.
