

Purpose

We are proposing to improve 7.5 miles of US 45 from Givens Road to Church Road, in Waupaca and Outagamie counties.



The US 45 pavement is showing signs of deterioration. The pavement was originally constructed in the mid 1990s.

Needs identified along this section of US 45 include:

- Deteriorating pavement surface
- Guardrail improvements
- Curb and gutter repair/replacement


Proposed improvements include the following:

- Remove and replace the existing asphalt
- Replace guardrail
- Replace curb and gutter at Spurr Road, County D, and Church Road
- Replace spot curb and gutter throughout project

Proposed traffic impacts

Construction is currently scheduled to begin in 2026.

During construction, US 45 will be closed to through traffic with a signed detour. The detour will utilize WIS 96 and WIS 76. Traffic crossing US 45 at WIS 15 and County D will be maintained.



Access to adjacent properties will be maintained during construction. Brief interruptions in access may occur temporarily at driveways. The contractor will be required to notify homeowners and businesses prior to construction.

Construction is currently scheduled for completion in fall 2026.
