#### **Purpose**

The objective of this meeting is to gather your input regarding the proposed improvements and traffic management strategies during construction. A brief presentation is scheduled to begin at 5:10 p.m. The remainder of the meeting will follow an open house format. Displays showing the proposed improvements are available for viewing. Project representatives are available to answer questions one-on-one.

#### **Project Information**

We are proposing to improve 0.79 miles of WIS 107 from approximately 1,140 feet south of 8<sup>th</sup> Street to approximately 180 feet north of North Street.

The purpose of the proposed project is to preserve the roadway asset and minimize the overall life cycle cost of the corridor. This can be accomplished by addressing the following needs:

- Deteriorating pavement
- Substandard geometrics
- Substandard pedestrian curb ramps
- Culvert and storm sewer deterioration

#### Deteriorating pavement:

The existing WIS 107 pavement is showing signs of distress with longitudinal and transverse cracking. These cracks allow water and deicing chemicals to enter the pavement and accelerate the deterioration of the roadway corridor.

#### Substandard geometrics:

The geometrics at the WIS 107 and 4th Street intersection do not adequately accommodate the required turning movements from large trucks that use this intersection, resulting in their rear wheels over-tracking up onto the curb and sidewalk. Trucks need to encroach into the southbound lanes when making the westbound to northbound turns.

#### Substandard pedestrian curb ramps:

Curb ramps located within the project corridor do not meet current Americans with Disability Act (ADA) standards.

#### Culvert and storm sewer deterioration:

There are two culverts that are deteriorating and nearing the end of their service life. The concrete adjusting rings inside the storm sewer structures are deteriorating.

#### Proposed improvements include:

- Resurfacing the existing roadway by milling off the top 1.75" of surface and replacing it with a new 1.75" layer of hot mixed asphalt pavement.
- Widen the WIS 107 and 4th Street intersection by pulling back the curb and gutter in the northeast corner. A porkchop island would also be added to the northeast corner to help channelize westbound to northbound turning trucks.
- Upgrade pedestrian curb ramps to current ADA standards.
- Replace one cross culvert pipe near the project beginning.
- Remove one culvert in the southwest corner of 8th Street and regrade the existing ditch to a new storm sewer drain.
- Repair deteriorated storm sewer structures.

#### **Proposed traffic impacts**

Construction is currently scheduled to begin in early summer of 2026 and will take approximately two to three months to complete.

During construction, WIS 107 will be resurfaced while open to traffic using single-lane closures with flagging. The upgrades to the WIS 107 and 4<sup>th</sup> Street intersection will be completed in stages to maintain traffic.

Pedestrians will be allowed access through the corridor at all times with the use of temporary pedestrian accommodations and staging of the curb ramp closures. Access to residences and businesses along the corridor will be kept open.

#### Real estate

Additional right of way will be required for this project. Permanent Fee right of way and/or Temporary Limited Easements will be required from most of the properties located in the intersection corners. The additional right of way is needed to construct the new pedestrian curb ramps and for blending the ramps into the existing ground behind the ramps. Preliminary right of way impacts are shown on the exhibits. WisDOT expects to begin real estate acquisition in July 2024.
