
# **Purpose**

The Wisconsin Department of Transportation (WisDOT) is in the process of developing plans for proposed improvements of WIS 153 in Marathon County.

# **Project Information**

We are proposing to improve approximately 12 miles of WIS 153 from Stainless Avenue to WIS 107, located in the village of Stratford, town of Cleveland and town of Emmet.

The objective is to provide information regarding the proposed improvements and real estate needs, describe the potential impacts it would have on the community, and offer an opportunity for public comment.



## **Proposed Improvements**

This is a pavement resurfacing project. Proposed improvements include:

- Asphalt milling and overlay
- Concrete joint and crack repairs in the concrete segment located west of Jasper Avenue to WIS 97
- Remove the bypass lane near Stainless Avenue and replace it with a 5-foot paved shoulder
- Upgrade curb ramps to meet Americans with Disabilities Act (ADA) standards (approximately 16 curb ramps)
- Extend the sidewalk between Legion Street and 4<sup>th</sup> Avenue along the north side of WIS 153
- Widen the paved shoulder from 3-feet to 5-feet between 4<sup>th</sup> Avenue and Karen Lane
- Replace the curb and gutter between WIS 97 and Legion Street along with spot repairs as needed within the village of Stratford
- Inlet repairs at select locations within the village of Stratford
- Replace select culverts (approximately 17 locations)
- Replace existing guardrail (approximately 20 locations)
- Intersection improvements at County M, County S and Emmet Road
- Install no parking signs along WIS 153 in the village of Stratford
- Replace pavement marking and install centerline rumble strips to maintain safety

## **Proposed traffic impacts**

Construction is currently scheduled to begin in July 2026.

During construction, motorists can expect to encounter daily flagging operations and single lane closures. During the culvert replacements, WIS 153 will temporarily be closed and detoured. Pedestrian accommodations will be provided within the village of Stratford during the curb ramp replacements.

Access to adjacent properties will be maintained during construction. Brief interruptions in access may occur temporarily at driveways. The contractor will be required to notify homeowners and businesses prior to construction.

Construction is currently scheduled for completion in October/November 2026.

### Real estate

Additional right of way will be required for this project. This will include small areas of permanent (fee) and temporary (temporary limited easement) land acquisitions to accommodate the improvements. Preliminary right of way impacts are shown on the exhibits posted on the project website. WisDOT expects to begin real estate acquisition in spring 2024. Direct mailings and coordination will occur with impacted property owners.
