### **Purpose**

WisDOT is holding this in person meeting today to gain additional insight from the public regarding the proposed improvement to WIS 22 (Church Street) from WIS 23 to just north of Park Street. This public input will be incorporated into our design as much as possible and all comments will be documented as a part of our design process.

### **Project Information**

We are proposing to improve 0.3 miles of WIS 22 from WIS 23 to approximately 480' north of Park Street. The existing WIS 22 pavement is showing signs of deterioration in the form of cracking and wheel path rutting. In addition to the deteriorating pavement, the WIS 22 intersection with WIS 23 does not accommodate turning movements for large trucks and farm equipment that frequently use the two highways. The purpose of the proposed action is to preserve the roadway asset and minimize the overall life cycle cost of the corridor. The public input process will add to our understanding of the existing roadway issues and conditions.

Proposed improvements include: The preferred alternative proposes to reconstruct WIS 22 throughout the corridor. Other project work would include replacing storm sewer, constructing new and replacing existing sidewalk and curb ramps, upgrading the WIS 23 intersection, and replacing city-owned sanitary sewer and water main facilities. Approximately 22 parcels will require a Temporary Limited Easement (TLE) and/or right-of-way acquisition throughout the corridor.

The preferred alternative addresses the roadway pavement deficiencies, intersection geometric deficiencies, deteriorating storm sewer, sanitary sewer and water main systems, and curb ramp deficiencies. This alternative will preserve the roadway assets, while minimizing overall lifecycle cost of the roadway corridor.

The environmental study is still ongoing at this time. The historical and archaeological studies were updated from prior phases of the design and no impacts are anticipated at this time.

# Proposed traffic impacts

Construction is currently scheduled to begin in Spring 2027.

During construction, WIS 22 will be closed to through traffic during construction. Through traffic will be detoured on WIS 73 and WIS 23 via the City of Princeton. Access to homes and business will be maintained at all times. Temporary driveway closures will be necessary during parts of the construction process. WisDOT will contact homeowners and businesses in advance before closing a driveway.

Construction is currently scheduled for completion late Summer of 2027.

#### Real estate

Additional right of way will be required for this project. Approximately 22 parcels will require a Temporary Limited Easement (TLE) and/or right-of-way acquisition throughout the corridor. We anticipate TLE's will be required for all properties south of Park Street. Minor Right of Way purchases will be needed at the intersections for curb ramp and intersection improvements at WIS 23. Preliminary right of way impacts are shown on the exhibits. WisDOT expects to begin real estate acquisition in July, 2024.
