

Purpose

The purpose of public involvement is to present design concepts for the proposed improvements along WIS 29, address impacts to traffic during construction and to obtain your input.



Project Information

The purpose of the project is to address WIS 29 pavement in the westbound lanes from WIS 13 Bridge to County E South. The existing concrete pavement has longitudinal cracking and isolated transverse joint deterioration. The westbound off ramp at Silver Maple Lane is in very poor condition. The existing asphalt shoulders are nearly 30 years old and are in poor condition.

Further, the guardrail along this stretch is in need of replacement to update to current standards. Pedestrian curb ramps at WIS 13 will be brough up to standards.

Proposed improvements include:

- Patching deteriorated areas of concrete along the westbound lanes
- Replace the westbound off ramp at Silver Maple Lane with concrete pavement
- Remove and replace the asphalt shoulders
- Evaluate and update the guardrail within the project limits
- Evaluate and update the curb ramps along WIS 13 at the westbound WIS 29 ramps

An environmental document is being prepared to address potential impacts to environmental resources along the project corridor.

Proposed Traffic Impacts

Construction is currently scheduled for the summer of 2025.

During construction, WIS 29 will remain open to traffic during construction by utilizing crossovers at each end of the project. One crossover will be just west of the County E South intersection, and the second crossover will be just east of the westbound off ramp to WIS 13.

The westbound off ramp at Silver Maple Lane will be closed while traffic is bi-directional on the eastbound lanes.

WIS 29 westbound on and off ramps will have short term closures, these closures will not take place while Silver Maple Lane westbound off ramp is closed.

No work will be performed, however, traffic may remain bi-directional in the eastbound lanes during the following Holidays:

- Memorial Day Noon Friday May 23 through 6 A.M. Tuesday May 27
- Fourth of July Noon Thursday July 3 through 6 A.M. Monday July 7
- Labor Day Noon Friday August 29 through 6 A.M. Tuesday September 2
