

### Purpose

The purpose of public involvement is to present design concepts for the proposed improvements along WIS 54, address impacts to traffic during construction and to obtain your input.



### **Project Information**

We are proposing to improve 1.5 miles of WIS 54.

The WIS 54 pavement is showing signs of deterioration. The existing pavement structure consists of asphalt overlaid with concrete. This atypical kind of overlay, concrete over asphalt, has resulted in an increased deterioration in the pavement, such as longitudinal and transverse cracking, spalling and shifting between slabs. The purpose of the project is to repair the deteriorating pavement.

Proposed improvements include:

- Replace deteriorated culverts under WIS 54 and several sideroads
- Remove 7-inches of the existing concrete pavement
- Remove 4-inches of the underlying asphalt pavement
- Place 6.25-inches of new asphalt pavement
- Upgrade guardrail to meet current standards
- New pavement markings
- Centerline rumble strips

An environmental document is being prepared to address potential impacts to environmental resources along the project corridor.

### **Proposed traffic impacts**

Construction is currently scheduled for 2031 but could be as early as 2025 if an advanceable date is chosen.

During construction, WIS 54 will be closed to through traffic. A posted detour will be in place utilizing County B and I-39.

Access to residences and businesses will be maintained on gravel. During culvert work there may be short periods of time where the road is closed completely directly at the culvert location.

Construction is currently anticipated to take one construction season to complete.
