How to Apply

- Choose 1-7 characters (except for a motorcycle plate choose 1-5 characters).
- If you choose 7 characters, you may request up to 2 spaces between any of the characters. Indicate this request with diagonal lines as shown here. **(This does not apply to a motorcycle plate.)**

- Use capital letters or numbers. The letter **O** and the number zero are the same. The following are not acceptable: small letters, symbols, signs, hyphens, apostrophes, etc. Carefully distinguish between:
 Letters **L** or **I** and Number **1** Letter **Z** and Number **2**
 Letter **S** and Number **5** Letter **B** and Number **8**
 Letter **G** and Number **6** Letter **U** and Letter **V**.
- Provide meaning of request, i.e., what does this represent?

- If the vehicle that you wish to register with personalized plates is already titled in your name, send:
 - * A copy of your Certificate of Registration OR the complete vehicle description on the application;
 - * **\$15.00** personalized plate fee plus annual registration fee if plates expire within the next 3 months for AUT, LTK and MTM plates.
 - * **\$30.00** biennial personalized plate fee plus biennial registration fee if plates expire within the next 3 months for CYC and FRM plates.
- If the vehicle is NOT titled in your name, send:
 - * A completed title application (MV1 or MV11) and fees, including annual registration fee;
 - * **\$15.00** personalized plate fee for AUT, LTK and MTM plates.
 - * **\$30.00** biennial personalized plate fee for CYC and FRM plates.

General Information

- ◆ A **\$15.00** personalized plate fee is required EACH year in addition to the regular annual registration fee.
- ◆ Biennial license plates for motorcycles or farm trucks require **\$15.00** personalized plate fee for EACH year of registration.
- ◆ If your request has already been issued to someone else, it will be denied.
- ◆ No refund or adjustment will be made for a change of choice or spacing after the plate has been ordered, or if the application is unclear or incorrectly completed.
- ◆ The department may refuse to issue a request which may be offensive to good taste or decency, misleading or conflict with the issuance of any other license plates.
- ◆ The department is authorized to recall, after issuance, a plate that is discovered to be obscene or otherwise offensive.
- ◆ If you are requesting a plate which the current owner no longer wants, "Release of Personalized Plates" must be completed and signed.
- ◆ Allow approximately 4-6 weeks for the manufacturing process, after Certificate of Registration is received.
- ◆ If you wish to just reserve the plates at this time, omit the vehicle information and check box: "Reserve Only."

Social Security Number

If you are applying as an individual, you are required to provide your Social Security Number, pursuant to 1997 Act 191, for the purposes of s.49.22 Wis. Stats. Under the Social Security Act, 42 USC s.405(c)(2)(C)(i), the department and other state and federal agencies may use the Social Security Number for purposes authorized by law.

Legal Operation

To legally operate your vehicle, you must display license plates within two business days of purchase. If you do not have current plates, apply to a DMV Customer Service Center or an agent authorized by DMV to obtain a temporary plate while your personalized plate order is processed. An agent may charge a \$3 plate fee and / or may also charge a \$5 service fee.

- ◆ Truck
 - ◆ 4,500, 6,000 or 8,000 pound gross weight including dual purpose farm, dual purpose motor home, and "for hire"
 - ◆ 12,000 pound gross weight farm truck
