

Greetings from the ETO/TIME team!

We hope you are having a safe and enjoyable summer! The TIME program is proud to announce that we have reached the national goal of 65 percent of first responders trained. We couldn't accomplish this goal without our partnership with our volunteer instructors and the organizations that sponsor these classes. According to FHWA, the Wisconsin TIME program is ranked #5 nationally, as far as TIM classes performed since 2014. We have set a new goal of 70 percent of first responders trained by the end of 2026. Again, your assistance is greatly appreciated!

Planning has begun for Crash Responder Safety Week (CRSW). This year we are planning to pursue proclamations from all 72 counties in addition to the largest 25 communities by population. Our intention is to spread the work across the state in support of our first responders. In 2024, we led the nation in proclamations supporting CRSW—recognition we intend to build upon in 2025!

#### **New Traffic Analysis and Safety Unit Supervisor**

#### Rural Road Safety Awareness Week—July 14-18

Rural Road Safety Awareness Week (RRSAW) is July 14-18 and it's all about clutching post-crash care for a big-league safety win.

Post-crash care improves the chances of surviving a crash by expediting access to medical care. It also prioritizes site safety and secondary crash prevention. The 2025 RRSAW awareness campaign's overall theme is, "Post Crash Care: Big League Safety."

"Post-crash care is the home run—the final safety net—in the Safe System Approach," said Jaime Sullivan, director of the National Center for Rural Road Safety. "It is especially critical in rural and Tribal communities, where jurisdictions are larger and first responder response times are longer, and emergency medical services (EMS) resources are usually limited."

This year's campaign takes on a baseball theme to encourage everyone to join the big-league safety team. Here are the daily themes:

- **Monday:** Hit a Grand Slam: Post-Crash Care on Rural Roads
- Tuesday: Assemble Your Dream Team: The Post-Crash Lineup
- Wednesday: Be a Pinch Hitter: Stop the Bleed, Save Lives
- Thursday: Change the Game: Extra Innings With Whole Blood
- Friday: Come in Clutch: Relief Pitching for First Responders

The campaign will use the hashtag #RRSAW2025.



#### Train-the-Trainer Courses

WisDOT's TIME program is always looking for new TIM instructors. Do you believe the proper application of TIM principles at an incident scene makes all responders safer? Do you believe that TIM principles result in the quicker clearance of an incident? Do you want to teach your fellow responders these valuable tools? Then the TIME program would like you to join its growing group of instructors.



The requirements for becoming and remaining a TIME program instructor are:

- 1) You must attend the eight-hour FHWA "Train-the-Trainer" instructor program.
- 2) You are asked to teach at least one four-hour responder class annually (to remain current with the material).

All TIM instructors are 100-percent volunteers. The program does not have any funds available to compensate instructors for their time or travel. They're passionate about incident scene safety and want to share their knowledge and experience with fellow responders. We try to have two instructors from different disciplines at each four-hour class, with one having the discipline from the requesting agency.

We will have two **free** train-the-trainer courses on the following dates:

- Aug. 18 from 8:30 a.m. to 5 p.m. at the Kalahari, 1305 Kalahari Dr., Wisconsin Dells, WI 53965. This is the day prior to the start of the Governor's Conference on Highway Safety. Please submit an application to attend the training by July 15.
- Oct. 25 from 8:30 a.m. to 5 p.m. at the Oconto County Office of Emergency Management, 301 Washington St., Oconto, WI 54153. Please submit an application to attend the training by Oct. 13.

Lunch will be provided at both classes. Teaching materials, including the new 2025 FHWA TIM modules, will be provided. Please consider becoming a TIM instructor. It can be very rewarding!

The Regional Duty Officer

The ETO and TIME programs continue our series introducing Traffic Incident Management and Emergency Transportation Operations personnel within the Wisconsin Department of Transportation (WisDOT) Division of Transportation System Development (DTSD). This article will focus on the Regional Duty Officer (RDO).

An RDO is an on-call, 24/7 DTSD Region Director or Section Chief who provides supervisory support and guidance for the Regional Incident Management Coordinator (RIMC); performs as DTSD on-call management for the region; provides situational awareness to upper management in the region, bureaus and executive offices; and has authority in obtaining additional resources to manage an incident or escalate an incident to an emergency event.

When an RDO becomes involved with an incident beyond routine RIMC guidance, it is usually due to an escalation in the severity or a real impact of the event. An RDO has authority to provide resources that mitigate emergency impacts including contractor authorization without competitive bid, deployment of county highway department resources or closure of an affected section of highway or bridge.

An RDO becomes involved in an incident through communication with the RIMC. RIMCs will remain the point of contact for first responder agencies and communicate directly with the RDO as resource requests arise. As a reminder to all first responder agencies, agencies are requested to contact the TMC for any incident that is anticipated to have at least one state highway lane or ramp blocked for more than 30 minutes.

For more information on the RDO in your region or their role in incident response, please reach out to the ETO and TIME programs. An RDO's authority to deploy region resources during incident response operations can be very beneficial to first responder safety and efficiency.
