An ordinance to revise and amend the General Code of Ordinances of the Town of Dewey.

The Town Board of the Town of Dewey, Portage County, Wisconsin do ordain as follows:

Section 1. The Code of Ordinances in book form entitled, "Municipal Code of the Town of Dewey, Portage County, Wisconsin", specifically Chapter 17, Ordinance to Opt-In for Category B –IOHs to Comply with the Table of Statutory Weight Limits under Sec. 348.15(3)(g), having been placed on file and open to public inspection in the office of the Town Clerk for a period of two weeks, commencing on December 17, 2014, in accordance with the procedures provided under Sec. 66.035 of Wis Stats., is hereby adopted as the general Code of Ordinances of the Town of Dewey, Portage County, Wisconsin, and all previously adopted general ordinances of the Town of Dewey are hereby repealed except as provided in Section 2 of this Ordinance.

Section 2. The Code of General Ordinances hereby adopted shall not be deemed to repeal any ordinances of the Town of Dewey or any general ordinance or part hereof relating to the following subjects and not conflicting with any of the provisions of the "Municipal Code of the Town of Dewey, Portage County, Wisconsin".

Section 3. This ordinance shall take effect upon passage and publication as required by law.

Chapter 17 Ordinance No.2015-1

Ordinance to Opt-In for Category B – IOHs to Comply with the Table of Statutory Weight Limits under Sec.348.15(3)(g)

WHEREAS, 2013 Wis. Act 377 under Sec. 348.15 (9) (f) 1. Provides that there is no weight limitation per wheel, axle, or group of axles for Category B implements of husbandry as defined in Sec. 340.01 (24) (a) 1.b., but does apply gross vehicle weight limitations to these vehicle, and

WHEREAS, Wis. Stat. S.S. 348.15(9)(F)1. Authorizes the municipality or county to require compliance with axle weight limitations established under Sec. 348.15 (3)(g) for Category B implements of husbandry defined in Sec. 340.01(24)(a)1.b. on all highways inder its jurisdiction,

NOW, THEREFORE, BE IT HEREBY ORDAINED by the Town Board of the Town of Dewey, of Portage County, that pursuant to Sec. 348.15 (9) (f) of Wis. Statutes, all implements of husbandry (including Category B implements of husbandry defined in Sec. 340.01 (24) (a) 1.b.) may not exceed the weight limits imposed by Chapter 348.15 (3) (g) of Wis Statues.

FURTHER, BE IT HEREBY ORDAINED that to exceed the length and/or weight limitations on highways under this jursidiction a no-fee permit may be applied for from the municipal jursidiction.

FURTHER, BE IT HEREBY ORDAINED that pursuant to Sec. 348.27 (19)(b) 4m.a. in the event an application for a no-fee permit is made for a Category B implement of husbandry as defined in Sec. 340.01 (24)(a)1.b., the municipal jursidiction or county is required to provide an approved alternate route, which may include highways that are not under this jurisdiction if prior approval has been given by the jurisdiction over the alternate routes not under this entity's jurisdiction for operation of Caregory B implements of husbandry as defined in Sec. 340.01 (24)(a) 1.b.

FURTHER, BE IT HEREBY ORDAINED that this ordinance shall remain in effect until rescinded by further action of the board.

FURTHER, BE IR HEREBY ORDAINED that a copy of this ordinance shall be provided to the Wisconsin Department of Transportation to be posted on the state DOT website.
