

Notice of Advertisement for Consultant Services Within Bureau of Aeronautics

The Wisconsin Department of Transportation, Bureau of Aeronautics is accepting letters of interest from qualified firms to provide assistance to BOA.

Project Purpose and Need

The BOA requires consultant assistance in a consultant coordinator role, acting as an extension of WisDOT BOA staff.

Project Description

Provide a part-time professional engineer with 10-15 years of experience working on BOA projects. Expectation is to work 24-28 hours a week under a 1-year contract that can be renewed for up to two additional years.

Under the direction of a BOA supervisor, act as a consultant coordinator being the lead contact on airport specialty projects, including statewide crack seal/seal coat projects, Automated Weather Observing System Replacements (AWOS), Snow Removal and Mowing equipment purchases, and NextGen tree clearing projects. Tasks include assisting in the oversight of all project development phases: project formulation (including Airport Layout Plan pen & ink drafting), design (including plan and specification drafting), and construction (including periodic site inspection/acceptance inspections). To avoid conflict of interest, consultants would not be assigned projects in which their firm has been selected to work on project formulation, design, or construction. Work will be completed from the consultant's home office with occasional meetings in person at BOA. If construction projects are assigned, site visits may be required.

Extensive familiarity with WisDOT Standard Specifications for Airport Construction

Extensive familiarity with FAA Airport Improvement Program (AIP) Handbook

Extensive familiarity with FAA Advisory Circulars and Orders

Understanding of FAA requirements for Block Grant States

Understanding of BOA processes and procedures

Special Skills

Professional Engineer

A selection board will review the firm's qualifications and rank them for further consideration.

Only firms having recent similar experience on airport projects are invited to respond.

A firm's qualifications will be reported on the bureau's consultant report form, which can be downloaded from the Wisconsin Department of Transportation Internet site at <http://wisconsindot.gov/Pages/doing-bus/aeronautics/airports/forms.aspx>. Please submit three copies of the consultant report form. Firms that recently submitted a consultant report form for other projects will **not** have to file a new form unless they wish to amend a previously filed one.

It is required that a submittal be sent to the bureau stating a firm's desire to be considered for the above work. This submittal should include the firms understanding of the project, list of key personnel, and list of similar work experience, and a resume for the proposed staff member.
