

**Notice of Advertisement for Consultant Services
For
Airport Pavement Condition Evaluation using PCI Procedure
Airports in the State of Wisconsin Airport System**

The Wisconsin Department of Transportation, Bureau of Aeronautics, as agent for public use airports throughout the state, is accepting letters of interest from qualified firms. A selection board will review the qualifications of interested firms and rank them for further consideration. Services required for this project will consist of, but are not limited to the tasks below for approximately one third of the public airports in the state per year for a 3-year term:

- Airport records review and network definition
- Pavement Evaluation (using PCI procedures as defined in FAA AC 150/5380-6C & current ASTM Standard D5340)
- Update the Department's existing Airport Pavement Management System database.
- Develop pavement maintenance and rehabilitation programs for individual airports
- Preparation of pavement reports for individual airports and the statewide network of airports
- Pavement Capacity and forensic studies as needed
- Development of Pavement Classification Numbers (PCN) for some select airports/airport pavements as needed
- Deliverables will be required to have been received the end of each calendar year for the designated one third of the airports that were surveyed that year.
- Distress density calculations for each or select pavement sections analyzed in the pavement evaluations.
- Statewide analysis of performance measures based on pavement type and square footage, as requested
- Provide and host, a web-based database of data gathered and reported in the above bullet points, accessible to the public.

Only firms having recent similar experience on airport projects are invited to respond. A separate selection may be made for various portions of the work.

A firm's qualifications shall be reported on the bureau's Consultant Report Form can be downloaded from the Wisconsin Department of Transportation Internet site at [Wisconsin Department of Transportation Forms and documents \(wisconsindot.gov\)](http://wisconsindot.gov). When submitting a Consultant Report Form, please send three copies.

Firms that have recently submitted a Consultant Report Form for other projects will not have to file a new form unless they wish to amend one previously filed. It is required however, that a letter be

sent to the bureau stating a firm's desire to be considered for the above work. The letter must include a list of key staff proposed for the project, an explanation as to how the above goals and deliverables will be met, access to an example of the web-based database, and an example of a PCI report previously generated (does not need to be a Wisconsin airport)
