WHAT IS ASP-3?

- ▶ ASP-3 : Additional Special Provision 3
 - Contractual element attached to all projects that have a DBE goal
 - DBE goals are only set on projects with Federal Funding
 - Provides guidance for meeting requirements of 49 CFR Part 26
 - Resource for DBEs, Primes, and other Contractors related to:
 - DBE participation – documentation submission requirements
 - GFE (Good Faith Effort) requirements, activities, and documentation
 - DBE credit evaluation
 - DBE commitment modification



ELECTRONIC BIDDING KEY PROCESS CHANGES

▶ Implementation

- Soft launch, October, November, and December 2020
 - Bid is NOT non-responsive if DBE documentation is missing or incomplete at time of bid

- Full implementation, January 2021
 - Bid IS non-responsive if DBE documentation is missing or incomplete at time of bid

ELECTRONIC BIDDING

KEY PROCESS CHANGES, CONTINUED

- ▶ ALL bids submitted for proposals with DBE goals require attachments at the time of bid
 - DT1506 (Commitment to Subcontract to DBE)
 - Attachment A **or** DBE quotes
 - DT1202 (Documentation of Good Faith Efforts), if DBE goal is not met
- ▶ Letting ends at 11:00:00 AM, second Tuesday of the month
- ▶ Bidders have 24-hours after bid letting has ended to submit
 - DT1202 supplemental documentation and Attachments A via DBE_Alert
 - Attachments A signed by DBEs included in commitment (DT1506) via DBE_Alert
- ▶ As read bid results will be posted beginning at noon, Wednesday
- ▶ Initial awards will occur the week after the letting



ELECTRONIC BIDDING

KEY PROCESS CHANGES, CONTINUED

- ▶ Submit Supplemental documentation by 11:00 AM Wednesday following let to:
 - ▶ DBE_Alert@wi.dot.gov
- ▶ Naming conventions for email subject:
 - “Project #, Proposal #, Let date, Business Name, Bid Attachment A”
 - “Project #, Proposal #, Let date, Business Name, 1202”



TECHNOLOGY REQUIRED

- ▶ AASHTOWare Project Bids™
- ▶ Access to electronically bid; www.bidx.com
 - Request an InfoTech Digital ID and Password from Bid Express™
 - Request to bid with WisDOT, using Bid Express™
- ▶ Request to be an eligible bidder with WisDOT (BPRS application)
 - <https://trust.dot.state.wi.us/bprs>



BID SUBMITTAL PROCESS

- ▶ Processes that have not changed
 - Logon Bid Express™
 - Locate and download Letting – Proposal .EBSX file
 - Open .EBSX file
 - Enter bid items



ENTER MISCELLANEOUS DATA

- ▶ All bidders are required to fill in questions 1 and 2
 - this requirement has not changed

1. Submitting a printout with Accompanying Electronic File.

2. I agree to the Internet Bid Submission Certification.



ENTER MISCELLANEOUS DATA, CONTINUED

- ▶ Attachment Requirements Summary
 - If a proposal contains an assigned DBE Goal, the following DBE information will be displayed

----- DBE INFORMATION -----

All required DBE forms, must be attached and submitted at time the of bid. All bids on proposals containing an assigned DBE goal must include completed DT1506 (Commitment to Subcontract to DBE) and Attachment A for each DBE subcontractor. If the DBE goal is not met, the bidder is also required to submit a completed DT1202 (Documentation of Good Faith Effort). Supplemental DT1202 documentation must be submitted to the DOT DBE Certification Alert Mailbox: DBE_Alert@dot.wi.gov by 11:00:00 AM the day after the letting has ended.

Beginning with the January, 2021 Letting, bids submitted without the required DBE attachments and supplemental documentation, will be deemed Non-Responsive.



ENTER MISCELLANEOUS DATA, CONTINUED

- ▶ Also, the DBE information for this proposal will be displayed
 - The DBE goal percentage is displayed
 - Note: You are no longer required to enter the DBE commitment percentage

This proposal has a DBE goal of **8.00%**, attach the required completed forms.
Note: 5MB file size limit per attached file.
