General Reminders:

- Please take time to review ASP-4 which covers retainage prime contractors are not allowed to withhold retainage without first documenting "just cause" (See attached).



Bid Day Reminders:

- If your company has not signed up for eSubmit, please take some time <u>this week</u> to do so. eSubmit is the preferred method for submitting DBE attachments, however at this time GFE documentation is still accepted through the DBE Alert mailbox. <u>Beginning with the October 2022 bid letting, letting documents will no longer be accepted through the DBE Alert mailbox.</u> Taking the time now will allow our office to approve and test any eSubmit issues, so your company is prepared on bid day (eSubmit instructions are attached).
