GFE Reminders

The best way to demonstrate Good Faith Effort (GFE) is by meeting the assigned DBE goal. We recommend that prime contractors continue to work with DBEs during the entire bid letting process – the DBE Office considers NEUTRAL DBE participation on the GFE Rubric as a demonstration of Good Faith Effort.

NAICS codes

Prime contractors are responsible for checking DBE NAICS codes on the <u>UCP DBE Directory</u> for any work being claimed by a DBE for DBE credit on that project.

GFE 1:1 Sessions

The DBE Program Office recommend that prime contractors who submit bids on WisDOT projects schedule an appointment at least once a year with the GFE Analyst to address any concerns or questions regarding Good Faith Effort and discuss areas of opportunity to strengthen your company's GFE request.

Agenda Item #5	Business Group Discussions – Tim McMurtry / David Hubbard Participation Goals: Marquis and Tondra explained how goals are set based on project size, location, and type. Prime–DBE Relationships: Building connections is often as simple as a phone call or email. Ongoing communication is key for clarity and engagement. Travel for Work: Firms must be willing to travel for opportunities and step out of their comfort zones. Consultant vs. Contractor Work: Emphasized relationship-building and quality-based selection over low bids. Communication Challenges: Disconnects between primes and subs highlight the need for clear expectations. Newer firms may struggle with jargon and hesitate to ask questions. Main Takeaway: Success depends on communication, adaptability, and proactive relationship-building.
	 Labor Group Discussions – Dan Webster / Maggie Givens \$300K Workforce Grant: To expand HCST in NE and NW Wisconsin, with \$75K in matching funds. Pre-Apprenticeship Reentry Program: Held at Sanger B Correctional; 9 of 10 graduated, 3 now job-seeking. Big Step Grant: \$10M to support youth trades programs and apprenticeships in Appleton. Data Issues: Some HCST graduates not accurately reflected in reporting; improvements are underway. Staff Change: HCST tribal coordinator Noel is leaving; recruitment for replacement in progress. Follow-Up Request: One-on-one meeting requested to discuss grant opportunities in detail.
