


















GFE Evaluation Rubric

- Left column documentation required on Form DT1202 (Documentation of Good Faith Effort)
- Evaluation Categories from guidance provided in 49 CFR Part 26
- All activities documented are totaled

ACTIVE & AGGRESSIVE: Demonstrated through engaged and assertive activity

QUALITY: Demonstrated through essential character of conscientious and serious activity

QUANTITY: Demonstrated through a measurable number of activities

SCOPE & INTENSITY: Demonstrated through a rigorous approach to an appropriate and purposeful

range of activities

TIMING: Demonstrated through engagement efforts beyond simple solicitation, initiated early in the process

BUSINESS DEVELOPMENT INITIATIVES: Demonstrated by efforts to support business growth and health of DBEs

Rating Scale



GFE EVALUATION - PHASE 2 - Team Review

DBE Office completes:

- Review of guote comparisons submitted by Prime
- Bid analysis to confirm if any bid submitted met the DBE goal
- · Review average of other bidders DBE goal achievement
- . Team review of combined efforts documented in Phase 1 and 2 by apparent low bidder

Excerpt from Appendix A to 49 CFR Part 26:

V. In determining whether a bidder has made good faith efforts, it is essential to scrutinize its documented efforts. At a minimum, you must review the performance of other bidders in meeting the contract goal. For example, when the apparent successful bidder fails to meet the contract goal, but others meet it, you may reasonably raise the question of whether, with additional efforts, the apparent successful bidder could have met the goal. If the apparent successful bidder fails to meet the goal, but meets or exceeds the average DBE participation obtained by other bidders, you may view this, in conjunction with other factors, as evidence of the apparent successful bidder having made good faith efforts. As provided in §26.53(b)(2)((vi), you must also require the contractor to submit copies of each DBE and non-DBE subcontractor quote submitted to the bidder when a non-DBE subcontractor was selected over a DBE for work on the contract to review whether DBE prices were substantially higher; and contact the DBEs listed on a contractor's solicitation to inquire as to whether they were contacted by the prime. Pro forma mailings to DBEs requesting bids are not alone sufficient to satisfy good faith efforts under the rule.

- Phase 1 Initial Review
 - Documentation of **Good Faith Effort** (DT1202) activity recorded in Rubric
- Phase 2 Team Review
 - Review overall efforts documented with DT1202 + achievement of other bidders

Bid Analysis

Goal 8%	Achieved %
Low Bidder	7.39%
Bidder A	3.54%
Bidder C	9.52%
Bidder D	4.33%
Bidder E	5.89%
Average of OTHER bidders (Not Including Low Bidder)	5.82%

Received 15 DBE quotes. DBE 1 and DBE 2 both submitted multiple quotes to subcontractors bidding on the structures. They both received an award through the low quote subcontractor.

DBE Quotes Rejected:

- DBE 1 and DBE 2 submitted quotes for sawing. DBE 1 was 17% high and DBE 2 was 13% higher than DBE 3 who was awarded the subcontract. (\$1,300.00 and \$960.00 versus \$1.084.00)
- DBE 2 was 21% higher for landscaping than DBE 4. (\$31,266.00 versus \$24,856.00)
- o DBE 5 was 82% higher for sewer materials than DBE 6 but bidder used DBE 5 for both geotextiles and sewer materials. (\$9,410.40 versus \$5,185.44)
- DBE Trucking 1 was 5% higher than DBE Trucking 2 (\$15,750.00 versus)
- DBE 7 was 308% higher for QMP Testing than non-DBE. (\$1,695.00 versus \$415.00.
- DBE 8 was 147% higher for staking than non-DBE. (\$19,565.55 versus \$7,918.45)
- DBE 9 quote for rebar was rejected because bar steel was included in another sub's overall quote that was selected.

DBE Quotes Awarded:

- DBE 1 \$24,856.00
- DBE 2 \$12,095.70
- DBE 5 \$9,410.40
- o DBE 9 \$101,524.00
- DBE Trucking 2 \$15,000.00
- o DBE10 \$1,084.00

Documentation review:

- Advertised in the Daily Reporter from 12/21-2020 through 1/4/2021
- Utilized SBN uploading information on 01/05/2021. (6 working days prior to bid letting.)
- Sent out e-mail solicitation on 12/21/2020 to 73 DBEs. (15 working days prior to bid letting.)
- · Solicitation requested quotes in the following work types: clear and grub, trucking, curb, gutter, sidewalk, erosion control, signs, posts, markers, traffic control, electrical work, traffic signals, pavement marking, sawing, pipe materials, field facilities, staking, QMP (base/subgrade/concrete), pipe underdrain, excavation, trees, shrubs, architectural surface treatment and asphalt.
- Solicitation included information on how DBEs can obtain plans and specifications, e-mail, phone, fax and cell phone numbers and contract person that DBEs can obtain assistance, answer questions and obtain additional needed information. Also included important changes to process in red.
- . 73 follow-phone calls were sent to DBEs on January 6, 2021 (7 working days prior to bid
- WisDOT DBE Support Services was sent letter requesting assistance on 12/21/2020.
- . DBE Program Chief was contacted on 12/21 to request feedback on GFE documentation
- . Included a summary of all trucking firms used including DBE and non-DBE.

• Phase 2 – Team Review

- Examine cost comparisons and sound reasoning for rejecting DBEs
- Review achievement of other bidders
- Complete review considering efforts documented by apparent successful bidder and achievement of other bidders
- If bidder has documented Bona Fide good faith efforts and achieved or exceeded average goal attainment that may be considered satisfaction of GFE
- If bidder has not documented Bona Fide GFE the request is denied



















Administrative Reconsideration

- The bidder can appeal a denial of GFE request
 - Within 5 days of notification of GFE denial from WisDOT
 - Refuting specific reasons for denial stated in the notification
 - Can request in person meeting
- Decision of Administrative Reconsideration is final
 - If denial of GFE is upheld the contract will not be awarded to that bidder
 - If denial of GFE is overturned the contract may be awarded to that bidder in respect to the DBE requirements













Electronic Bidding- Key Process Changes

- Implementation (DBE Bid Documentation)
 - Soft launch, October 2020 April 2021
 - Bid is NOT non-responsive if DBE documentation is missing or incomplete at time of bid
- Full implementation, May 2021
 - Bid IS non-responsive if DBE documentation is missing or incomplete at time of bid













Electronic Bidding- Key Process Changes


- ALL bids submitted for proposals, with DBE goals, will require attachments at the time of bid
 - DT1506
 - WisDOT is working on integrating DT1506 into Bid Express
 - Attachment A or Quotes
 - DT1202, if DBE goal is not met
- Letting ends at 11:00:00 AM, second Tuesday of the month













Electronic Bidding- Key Process Changes


- Bidders have 24-hours after the bid letting has ended (11:00:00) AM Wednesday) to submit:
 - Attachment A's (if not submitted at the time of bid)
 - DT1202 supplemental documentation
 - **NOTE:** Attachment A's and/or Supplemental Documentation to the DT1202 are to be submitted via eSubmit (preferred) or emailed to the DBE_Alert@dot.wi.gov
- As read bid results will be posted beginning at noon, Wednesday
- Initial awards will occur the week after the letting

 - Request to bid with WisDOT, using Bid Express[™]
- Request to be an eligible bidder with WisDOT (BPRS) application)














Bid Submittal Process

- Locate and download Letting Proposal .EBSX file
- Open .EBSX file
- Enter bid items











Attach DBE Documents

DBE Commitment Form DT1506/Attachment A or Quote/DT1202

Note: If the file is larger than 5mg, the file will not be uploaded to Bid Express™



- Enter a description for the file uploaded
- Such as; 20201013001 DT1506
- Click Browse to locate the required file to attach
- Attached files can be previewed


