WisDOT's Contact List Leaks, Spills and Other Hazardous Materials - Who do you call?

Spills from Crashes or other Highway Incidents:

Use the 24-hour Emergency Response Hotline. WDNR responds to emergency situations, DNR pursues the responsible party for cleanup. DNR may request DOT assistance for traffic control within a construction zone, or identifying the outfall for a stormwater conveyance system. In certain circumstances DOT may pursue site restoration through the damage claims process. To determine whether or not a damage claim may be needed, contact DBM Risk Safety and Facilities Management, Luke Kass 608-267-5132, or 608-977-1026 (M).

Spills on the Right of Way not related to a crash or incident

If you need assistance in stopping or containing the spill, use the Emergency Response (24-hour) hotline:1-800-943-0003. To report a spill contact the Department of Natural Resources (DNR) 24-hour Emergency Response Hotline.



Agricultural Product Spills

To report an agricultural product spill, contact the 24-hour Emergency

Response Hotline. The Department of Agriculture, Trade and Consumer Protection (DATCP) spill coordinator (Alan Hopfensperger (608) 609-5213.) will respond.



Dry Fertilizer: Report the discharge to the Spill Hotline if the amount is 250 lbs. or greater.

Liquid Fertilizer: Report the discharge to the Spill Hotline if the amount is 25 gallons or greater.

Registered Agricultural Pesticides: Report the discharge to the Spill Hotline if the amount, when diluted according to the label, would cover one acre or more of land if applied according to the label instructions.

If you spill products other than fertilizer or pesticides, call the Emergency Spills Hotline to see if it must be reported.

Abandoned Containers

Contact the 24-hour Emergency Response Hotline for containers that are leaking. For non-leaking stable containers you can contact the Spill Coordinator in the area the containers were found, and Notify Risk, Safety and Facilities Management

<u>Petroleum Spills by County Personnel, Contractor or Consultant (any quantity)</u> Contact DNR 24-hour Emergency Response Hotline. The county, contractor or consultant is responsible for cleanup of the spill.

Hazardous Waste Spills by DOT Personnel and Spills at DOT Non-Highway Facilities
