Re: 2025 PLANT CERTIFICATION, FUTURE TRANSITION TO AASHTO CMP AUDIT PROGRAM

To: WisDOT Corrugated Metal Pipe Product Suppliers

The purpose of this letter is to notify you of updated requirements for plant certification for production of corrugated metal pipe (CMP) products procured by the Wisconsin Department of Transportation (WisDOT).

2025 Plant Certification: CMP Product Manufacturers

As of the effective date of this letter, all metal pipe products furnished to WisDOT projects must be fabricated in a facility that is compliant with the requirements of **one** of the audit programs indicated below.

- CMP audit program through AASHTO Product Evaluation and Audit Solutions, or;
- WisDOT's state-led CMP products audit program.

It will not be necessary for plants to participate in both of the above-referenced audit programs for 2025. However, we require a response from you regarding which program you plant to participate in for next year. (See page 2 for more information).

Future Transition to AASHTO CMP Audit Program (for 2026 Plant Certification)

Moving forward, WisDOT plans to discontinue the state-led program and will adopt the AASHTO CMP audit program for future plant certification and acceptance. Acceptance of either program for the 2025 certification cycle will be allowed in the interim to support your facility in making the transition to the AASHTO CMP audit program. Following the next certification cycle, all facilities must be actively enrolled in the AASHTO CMP audit program by December 31, 2025, and have an AASHTO audit status of either "Scheduled" or "Compliant" in AASHTO Datamine, to remain on WisDOT's APL for 2026.

Enrollment in the program requires working directly with AASHTO Product Evaluation and Audit Solutions to complete the online application process, payment of required fees, and adhering to the requirements of the audit program. Please contact AASHTO Product Evaluation and Audit Solutions directly to complete the enrollment process.

Note that for 2025 audit cycle, the AASHTO application period opens on September 16, 2024 and closes on November 15, 2024.

Your Response is Required by September 30, 2024

For those plants already participating in the AASHTO CMP audit program, as long as your facility maintains active enrollment and remains fully compliant, a separate audit by WisDOT will not be required for 2025. Please send a copy of your current Certificate of Compliance Authentication to DOTproductsubmittal@dot.wi.gov and indicate the date of your next AASHTO CMP audit to remain on WisDOT's approved product list (APL) for next year. If you are new to the program for 2025 and do not yet have a Certificate of Authentication, please provide documentation of your enrollment (email from AASHTO) along with the scheduled date of your audit.

For those plants not participating in the AASHTO CMP audit program (and/or not planning to participate in the program for 2025), a state-led audit of your facility will be required. Please send an email with facility contact information to DOTproductsubmittal@dot.wi.gov confirming your need for a state-led audit so that we may plan accordingly, and WisDOT will work with our consultant to coordinate next steps. (Refer to the information in the previous section if you are considering moving forward with participation in the AASHTO CMP program for next year.)
