

Planned Solicitations for I-39/90/94 from Wisconsin Dells to Madison

Consultant Continuity Team Solicitation:

Support the modernization of 67 miles of I-39/90/94 from Dees Road to US 12/18 by providing a Corridor Team and a Design Coordination Team.

Corridor Team:

Design enhanced corridor continuity review: Perform enhanced design review. Plan reviews occur at 60/90%, minimally. Individuals performing reviews may not review documents produced by their firm under design contracts.

Public Involvement: Coordinate PIMs, manage public comments, update website, and review PIM materials.

Corridor: Geometrics, structures, drainage, utilities, specs/materials, ITS/electrical, EC, flooding, signals/lighting, TPP, landscaping, and real estate.

Environmental: Coordinate, review, and submit re-evaluation.

Traffic: Provide work zone analysis, other traffic analysis, and IAJR updates.

Services also include use of unifier, administrative assistance, real estate staking, managing corridor manual, and assistance with design-build packaging.

Design Coordination Team:

Provide consultant project coordinator and project controls specialist to assist with each of the 4 segments. A consultant project coordinator's firm may not be selected as a prime or joint venture (P/JV) for the design segment the coordinator is assisting.

The selected firm, P/JV, may not be selected as a P/JV for any project controls or design segment solicitation. Construction inspection is allowed.

If any design-build projects are identified along the corridor, the P/JV firm(s) may not be part of the design-build team for those projects.

Project Controls Team Solicitation:

Support the modernization of 67 miles of I-39/90/94 from Dees Road to US 12/18 and 10 miles of US 51 from Voges Road to IH 39/90/94 by providing project controls services.

Program Controls: Assist with oversight and issue resolution. Coordinate meetings and record minutes, scheduling, file management, design document control, construction document control, construction finals tracking, management using Unifier, and all other necessary tasks to complete the project.

Scheduling: Develop/manage multiple schedules for projects and corridor.

Financial Reporting: Provide TPC updates two times a year and financial reports yearly.

The selected firm, P/JV, may not be selected as a P/JV for any corridor continuity or design segment solicitation. Construction inspection is allowed.

If any design-build projects are identified along the corridor, the P/JV firm(s) may not be part of the design-build team for those projects.

Design Solicitations:

Design solicitations for the 67-mile-long interstate corridor. Corridor is divided into four segments:

US 12/18 (Madison South Beltline) to just south of Hoepker Road
South of Hoepker Road to Richards Road
Richards Road to Sauk/Columbia County line
Sauk/Columbia County line to US 12/WIS 16

Design includes modernization and expansion plans for I-39/90/94 based on the environmental impact statement and includes the reconstruction of standard interchanges and overpasses. Deliverables include design from study to Plans, Specifications, and Estimates. Solicitation includes, but is not limited to, the completion of roadway plans, structure plans including noise walls, DSR, TMP, TPP, estimates, traffic staging, public involvement, geotechnical reports/borings, pavement design reports, field survey, stormwater design, environmental documentation and permitting, agency coordination, signal/lighting plans, local government coordination, utility coordination, railroad, and transparency services.

The segment between Richards Road to Sauk/Columbia County line includes raising the interstate, floodplain analysis, and a floodplain mapping revision and associated CLOMR (conditional letter of map revision) and LOMR (letter of map revision) documentation.
