## Summary: Title VI/Non-Discrimination Plan Required Elements<sup>1</sup>

Agencies and entities, referred to as "subrecipients" receiving federal transportation funds must develop a Title VI/Non-Discrimination Plan per <u>FTA Circular 4702.1B</u>. The Federal Transit Administration (FTA) and Federal Highway Administration (FHWA) have different approaches to Title VI/Non-Discrimination compliance. Subrecipients should know whether they are receiving only FTA funding, FHWA funding, or both.

Consult the <u>Title VI/ADA Handbook for Transit</u> and WisDOT Transit Section staff for guidance on plan requirements. The table below identifies required plan elements. Subrecipients may be required to provide additional information. Sample templates are available on the <u>Transit Title VI/ADA website</u>.
