**It is the responsibility of the applicant to determine if they qualify to use this form.**

Submit this form with the Wisconsin Certificate of Title, Title & License Plate Application (form [MV1](#)), fees, and lien release (if applicable). If there are more than two new owners for this vehicle, submit additional MV2300 forms as needed.

**Who may use this form:**

- A surviving family member or heir transferring a vehicle with a current Wisconsin title from a decedent to themselves, with or without a co-owner.
- A surviving family member or heir transferring a vehicle with a current Wisconsin title from a decedent to another owner.
- A surviving family member or heir applying for replacement title for a vehicle with a current Wisconsin title in the decedent's name.

**Qualifying surviving family members:**

DMV will waive the title transfer fee (and replacement title fee, if applying) and transfer existing license plates/registration if all owners on the new title are Wisconsin residents and are related to the decedent as:

- Spouse
- Domestic Partner (as defined in [Wis Stat. § 770.01](#))
- Grandparent or their spouse
- Parent or their spouse
- Sibling or their spouse
- Child or their spouse
- Stepchild or their spouse
- Stepparent or their spouse
- Grandchild or their spouse

**If any owner to be listed on the new title is not one of the qualifying family members listed above, the current title fee (and replacement title fee, if applicable) is required.**

**If the current Wisconsin title is lost:**

In addition to this form and form MV1, submit a Wisconsin replacement title fee and application (form [MV2119](#)), signed by the person authorized to apply on behalf of the decedent. The replacement title fee is waived for the surviving family members listed above, but an application (form [MV2119](#)) is still needed.

An MV2488 (Vehicle Transfer and Odometer Mileage Statement) may be needed if the transaction requires an odometer reading. See [Wisconsin DMV Official Government Site - Sell your vehicle \(wisconsindot.gov\)](#) for more information about completing an odometer statement.

If the lender holds the current title contact the lien holder for the current title (and lien release, if applicable).
