Purpose

The Wisconsin Department of Transportation (WisDOT) is in the process of developing plans for proposed improvements on approximately 2 miles of Business 51 in the Marathon County. The purpose of this handout is to provide information regarding the proposed improvements, describe the potential impacts, and offer an opportunity for public comment.

Your comments assist us in developing a project that will serve the needs of the traveling public as well as the needs of the local community and are welcomed and appreciated throughout the design process.

Included at the end of this handout, as well as on the project website, is a comment form that may be used for written comments regarding the proposed improvements. You are encouraged to fill out this form and return using the pre-paid mailer attached. Comments may also be submitted via email or phone to the contact listed below.

Project location

The project is located on Business 51 in the city of Schofield and the villages of Rothschild and Weston.



Project purpose and need

The pavement was reconstructed in 1967 and 1977 with concrete pavement with ongoing repairs and overlays have occurred between 1991 and 2020. The existing pavement is deteriorating with cracking and rutting throughout. The pavement has met the end of its service life

Additional needs include:

- Cracking concrete pavement on the WIS 29 loop ramps
- Deteriorating and undersized storm sewers
- Deteriorating and outdated guardrail
- Deteriorated sections of municipal sewer and water
- Lack of sidewalk on the east side from WIS 29 to Jelinek Avenue
- Curb ramps do not meet Americans with Disability Act (ADA) standards
- Failing concrete side slope (slope paving) between Ross Avenue and Drott Street
- Deterioration on the bridge deck over the Eau Claire River (B-37-280)
- Outdated traffic signal equipment at all signalized intersections (6)
- Ongoing crashes resulting in severe injuries at four intersections. The project qualified for safety improvement funding in 2021.

Safety needs

- WIS 29 eastbound ramp terminal
 - o 2014 to 2018: 68 total crashes
 - o 52 westbound rear-end crashes within the dual right turn lanes on exit ramp
- WIS 29 westbound ramp terminal/West Grand Avenue
 - o 2014 to 2018: 75 total crashes
 - 44 rear-end crashes along Business 51
 - 10 angle crashes during left turning movements
- Schofield Avenue/Metro Drive
 - o 2014 to 2018: 70 total crashes
 - Crash trends:
 - 18 crashes within northbound free flow right turn lane to eastbound Schofield Avenue
 - 17 crashes along westbound Schofield Avenue due to poor lane signing and marking
 - 6 crashes along eastbound Business 51 due to conflict with a driveway in the turn lane
- Eau Claire Street
 - o 2014 to 2018: 14 total crashes
 - o 7 northbound rear-end crashes caused by vehicles waiting to turn left
 - No existing left turn lanes at the intersection









Proposed improvements

The following improvements are proposed to address the project needs.

Pavement improvements

- Everest Drive to the Eau Claire River
 - o Full depth pavement replacement with new asphalt pavement
 - New curb and gutter
- WIS 29 loop ramps
 - o Repair the concrete pavement and repair drainage facilities

Drainage improvements

- Replace inlets and manholes from Everest Drive to Metro Drive
- Replace the entire drainage system from Depot Street to the Eau Claire River
 - o Flooding at low point under railroad overpass near Depot Street
 - Requires reconstruction of Eau Claire Street west of Business 51 and a portion of West Grand Avenue in the city of Schofield
 - Abandon the existing storm sewer system located on private property
- Replace the entire drainage system from Eau Claire Street to the Eau Claire River

Pedestrian improvements

- Replace all curb ramps to meet ADA standards, where feasible
- Construct new sidewalk along the east side of Business 51 between the WIS 29 eastbound ramp terminal and Jelinek Avenue

Traffic signals and safety improvements

- Install new traffic signals at all signalized intersections
 - o WIS 29 eastbound ramp terminal
 - WIS 29 westbound ramp terminal/West Grand Avenue
 - Ellen Street
 - Kort Street/Jelinek Street
 - Schofield Avenue/Metro Drive
 - Grand Avenue/Drott Street
- Geometric modifications to reduce crashes and improve safety at four locations
 - 1. WIS 29 eastbound ramp terminal intersection
 - Modify turn lanes on the exit ramp to improve traffic flow within the dual right turn lanes
 - 2. WIS 29 westbound ramp terminal/West Grand Avenue intersection
 - Modify the Business 51 left turn lanes with an offset
 - Improves sight lines for left turning traffic
 - 3. Schofield Avenue/Metro Drive intersection
 - Modify the northbound to eastbound free flow right turn lane
 - Lengthen the eastbound right turn lane
 - Modify the eastbound and westbound left turn lanes to improve traffic flow including replacement of the overhead sign
 - 4. Eau Claire Street intersection
 - Modify the intersection to provide for a northbound left turn lane
 - <u>Evaluate closure</u> of the east leg of the intersection with a cul-de-sac

Other improvements

- Replace sections of municipal sewer and water throughout the project
- Replace guardrail along the west side of Business 51 near Ross Avenue
- Construct a new retaining wall between Ross Avenue and Drott Street
- Relace the polymer overlay and place a flood seal on the bridge over the Eau Claire River (Structure B-37-280) to preserve the bridge deck
- · Replace signing and pavement marking

Proposed traffic impacts

Construction is currently scheduled for 2029 and 2030

• Construction could begin as early as the fall of 2028.

There will be numerous stages to manage traffic throughout the project area.

- Business 51 will be generally open to bi-directional traffic (one lane in each direction)
 - A short-term full closure may be required at Business 51/Drott Street/Grand Avenue to accommodate utility installations
 - o Driveway access would be right in/right out during various stages
- From Metro Drive/Schofield Avenue to Drott Street, Business 51 does not have a median
 - o One-way conditions will be required for various stages
 - o Detours will be posted along West Grand Avenue, Schofield Avenue and Ross Avenue
- Side road and ramp closures
 - o Closures required during some pavement and utility work
 - o Intersection and ramp closures are proposed to be staggered (i.e. every other intersection)
 - o Local and emergency circulation will be maintained
- Eau Claire Street and West Grand Avenue drainage improvements
 - o Roadways will be closed to through traffic during drainage work
 - Local and emergency access will be maintained

More details will be shared on sequencing and staging at future meetings. Frequent coordination will occur with property owners and businesses during construction to communication stages and changes in traffic control.

Real estate

Right of way and easements are required for the project at spot locations.

- Minor new right of way will be required near intersections for some intersection modifications and curb ramps.
- Temporary easements will be required for blending slopes, driveway match points, staging, and utility connections.
- Permanent easements and new right of way will be required for the storm sewer outfall to the Eau Claire River located west of Grand Avenue.

Preliminary real estate needs are shown on the exhibits.

A landowner rights pamphlet is available and WisDOT will contact any impacted property owners directly during the design process. WisDOT expects to begin real estate acquisition in fall 2025.

- Scope coordination with local officials and concept design spring 2022 to fall 2024
- Local officials meeting July 17, 2024
- Public involvement meeting Aug. 15, 2024 *
- Concept plans fall 2024
- Environmental document spring 2025
- Preliminary plans summer 2025
- Right of way acquisition fall 2025 to spring 2028
- Final plans May 1, 2028
- Business coordination meeting fall 2028
- Construction 2029 and 2030 **
 - *Additional public meetings will be held, as required, during the design and construction process.
 - ** Construction could begin as early as fall of 2028

END OF CONSTRUCTION




- Stay positive, be flexible and know that WisDOT staff are available to help
