

Purpose

The reason for the meeting is to share the upcoming US 10 project scope to business owners, the public, and real estate owners along project limits. This communication is planned to aid in answering questions and fulfilling information based on project intentions and plans in 2028. This format also allows feedback and questions to encourage project coordination and discussion.

Project Information

Construction is currently scheduled to begin in the Spring of 2028. We are proposing to improve 4.125 miles of US 10 in Stevens Point.



The existing US 10 Eastbound and Westbound pavement between I-39/US 51 and County J, as well as County J and the associated ramps, is showing signs of distress with low and medium severity longitudinal cracking along with weathering of the pavement surface. The existing cracks allow water and de-icing chemicals to enter the pavement and accelerate the deterioration of the roadway. This roadway will continue to deteriorate and fall below the recommended pavement quality if actions are not taken to enhance the existing roadway.



Two different levels of pavement work are planned to address the identified problem areas along this roadway.

Concrete Pavement Replacement

• For the areas that are identified as having the worst condition, a full depth concrete pavement repair and replacement is scheduled.

Continuous Diamond Grinding Concrete Pavement

Areas where joints and roadways are starting to show distress- they can be rehabilitated
using a continuous diamond grinding technique across the surface. This approach will
allow the least destructive approach to repair areas of the least concern.

Together, these two approaches plan to improve and extend the life of the roadway beyond its current estimate. This work would also be completed on the ramps at the County J interchange as well as County J between the ramp terminals.

Additional/ Incidental Work

- The existing asphaltic pavement Two-Way Left Turn Lane (TWLTL) will have the pavement surfaced milled and replaced with new asphaltic pavement.
- The existing asphalt pavement shoulders would be replaced with new asphalt pavement.
- The inlets along the roadway would have repairs completed based on condition.
- Some existing pipes would be removed and replaced in kind based on condition.
- Curb and gutter areas would be evaluated based on condition and replaced in kind.
- The existing concrete barrier in the median of US 10 near the County J interchange is anticipated to be repaired/replaced.
- The beam guard approaches to the County J structure over US 10 would be replaced to meet current design standards.

No other safety, parking, or roadway improvements are planned at this time outside of the previously mentioned.

Construction is currently scheduled for completion in Fall 2028.

Public Input

If there is any public input into the proposed improvements, we are open to discussing. If there is additional information that would like to be included there will be a public input/comments sheet to be filled out and submitted online or in the mail.

Proposed traffic impacts

Construction is currently scheduled to begin in the Spring of 2028

The proposed work can be performed while traffic is maintained on US 10. The construction zone will require temporary lane closures directing traffic to use the other lane or lanes as necessary. Temporary signal timings are anticipated to reduce delays. The ramps between US 10 and County J will be closed for nighttime work. Additional traffic information will be added as the traffic management plan is developed.

Temporary driveway closures may be necessary during parts of the construction process. WisDOT will contact homeowners and businesses in advance before closing a driveway. Access will always be available during hours of operation. Coordination with Businesses will be done to determine if there is any opportunity for short term access closures to reduce construction time.
