Purpose of Handout

To educate the public on the scope, schedule, and potential impacts of the Merrill to Tomahawk US 51 project. To also provide the public with an opportunity to comment and provide input.

Project Information

The project will extend the service life of the roadway.

We are proposing to improve 16.5 miles of US 51 with three projects.

- 1176-21-72 7.41 Miles from County K to County H
 - o concrete joint repair and slab repair with a four-inch asphalt overlay.
- 1176-21-73 6.16 Miles from County H to Little Pine Creek
 - o concrete pavement replacement
- 1176-21-62 2.93 Miles from County J to County S
 - o concrete joint and slab repair with a thin mill and overlay of the County S northbound and southbound ramps

Environmental review is expected to be completed by June 2025.

Proposed traffic impacts

Construction is currently scheduled to begin in 2028, with an advanceable construction as early as 2027.

During most of the construction, the roadway will be constructed one side at a time, closing one side for construction while the other side has bi-directional traffic. Existing crossovers at County K and County S may be utilized to accommodate this. Nighttime ramp closures are anticipated.

Real estate

This project is not anticipated to require any additional right-of-way or temporary land acquisitions.
