#### **Purpose**


Welcome to the public involvement meeting to discuss proposed improvements to US 8 between South Junction WIS 32 and the Peshtigo River Bridge in Forest County.

The purpose of this meeting is to:

- Present information regarding the current condition of the roadway
- Provide information about the proposed improvements
- Obtain your input
- Answer your questions

A brief presentation is scheduled to begin at 5:30 p.m. The remainder of the meeting will follow an open-house format with displays of the improvements available for viewing. WisDOT representatives will available to discuss the project and answer your questions.

The Wisconsin Department of Transportation (WisDOT) appreciates your participation and comments regarding this project. Public input will be incorporated into our design as much as possible and all comments will be documented as a part of our design process.

#### **Project Information**

We are proposing to improve 7.4 miles of US 8.

The purpose of this project is to extend the service life of the pavement, enhance safety, and maintain acceptable drainage along US 8 from South Junction WIS 32 to the Peshtigo River Bridge in the towns of Laona and Caswell.

The following needs have been identified on this section of US 8:

- The pavement is deteriorating
- Curb ramp & sidewalk deficiencies
- Drainage deficiencies
- Guardrail deficiencies

#### Proposed improvements include:

- Milling and resurfacing of US 8
- Upgrading guardrail to meet current standards
- Spot replacement of deteriorated curb and gutter and retaining wall
- Spot replacement of curb ramps and sidewalk sections that are deteriorated or do not meet current Americans with Disability Act (ADA) standards
- Replacement or repair of deteriorated culverts and replacement or repair of deteriorated storm structures

An environmental document is being prepared to evaluate and mitigate potential impacts to environmental resources along the project corridor. Historical and archaeological studies have been completed within the project area. Additional potential investigations and coordination that are upcoming include endangered species review, Wisconsin Department of Natural Resources (WDNR), and US Army Corps of Engineers (ACOE).

#### **Proposed Traffic Impacts**

Construction is currently scheduled for the summer of 2028.

During construction, US 8 will remain open to traffic utilizing daytime single lane closures, managed by flagging operations. There may be instances where staged construction or short-term closures at intersections are required. Motorists can expect some delays to occur, but delays will be managed through limiting contractor operations at critical times. Access to residences and businesses will be maintained except for short periods while construction operations are directly adjacent to the entrances. Temporary pedestrian facilities will be in place during the replacement of sidewalk curb ramps.

#### **Real Estate**

Areas of permanent right-of-way acquisition and temporary easements may be required to accommodate the proposed improvements. WisDOT expects to begin real estate acquisition in the winter of 2025.
