Purpose

The purpose of the US 8 public involvement is to:

- Present information regarding the current condition and needs of the roadway
- Provide information on the proposed improvements to US 8
- Obtain your input and answer your questions.

Project Information

We are proposing to improve 3 miles of US 8. The purpose of the proposed project is to address safety issues and improve pavement conditions of an important US highway in northern Wisconsin.

Deteriorating Pavement

 The current pavement has deteriorated in the form of visible cracking that is susceptible to tenting during the winter. The pavement also has alligator cracking and rutting.

Safety

 There have been multiple crash safety issues at the WIS 17 South intersection with a higher number of crashes than what would be expected for a similar intersection.

Proposed Improvements Include:

- Pavement replacement
- Convert the WIS 17 South/Boyce Drive and County G intersections into single-lane roundabouts





- Mill and overlay WIS 17 North intersection
- Replace guardrail on the east side of the Wisconsin River
- Replace culvert just east of WIS 17 South

Proposed traffic impacts

US 8 traffic from WIS 47 to WIS 17 North would be detoured and staged to minimize impacts to traffic and businesses. Traffic would be detoured along West Kemp Street, Arbutus Street, South Pelham Street, Courtney Street, Lincoln Street, and WIS 17 North. WIS 17 South traffic would be maintained by use of a temporary bypass of the WIS 17 South/Boyce Drive intersection to connect west to WIS 47. County G traffic would be maintained north-south using one-lane/two-way traffic signals through the work zone.

Real estate

Additional right of way will be required for this project. Small areas of temporary limited easements will be needed for grading at the two roundabouts.
