Purpose

The purpose of this handout is to present design concepts for the proposed improvements along WIS 139 and obtain your input.

Project Information

We are proposing to improve 10.7 miles of WIS 139 from US 8 to the Florence County line.

The purpose of this project is to address the deteriorating pavement and drainage features. The existing pavement is showing signs of distress, and several culvert pipes have deteriorated. The project is needed to provide a new driving surface, extend the life of the roadway and replace the deteriorating culverts.

Proposed improvements include:

- Partially milling the existing asphaltic surface and paving a new asphaltic surface.
- Replacing five culverts.
- Installing centerline rumble strips.
- Installing new pavement markings.

The environmental study is ongoing, and the project is currently being screened for archaeological or historical impacts.

Proposed traffic impacts

Construction is currently scheduled to begin in spring 2030, but work could occur as early as 2028.

During construction, WIS 139 will remain open to traffic using single-lane closures and lane shifts. Flaggers will direct traffic while work is ongoing. Motorists can expect some delays to occur, but delays will be managed by limiting the contractor operations at critical times. Access to residents and businesses will be maintained except for short time periods while construction operations are directly adjacent to the driveways. WisDOT will contact homeowners and businesses in advance before closing a driveway.

Construction is currently scheduled for completion by fall 2030.
