Purpose

The Wisconsin Department of Transportation (WisDOT) welcomes you to this public involvement meeting (PIM) for the proposed improvements to WIS 186 from WIS 73 to US 10 in the townships of Hansen, Sigel, Arpin, and Auburndale, and the villages of Vesper, Arpin, and Auburndale. Refer to Figure 1 on the next page for a project location map.

The objective of this meeting is to provide you with information regarding the proposed improvements to the roadway. WisDOT representatives will give a brief presentation starting at 5 p.m.

Please take time to review the information presented. WisDOT project representatives are available to answer questions. A public comment form is also available to you to provide written comments. Please submit all comments by Sept. 26, 2025.

Project Information

The purpose of the proposed project is to mill and overlay the existing pavement on WIS 186 that is showing signs of progressive cracking, patching, and rutting.

The work for the proposed project is anticipated be completed under three design (construction) IDs that are described below.


<u>Project ID 6620-00-00 (70)–5th Street to Oak Street:</u> The total project length of this section of WIS 186 is approximately 1 mile. The proposed improvements would include:

- Milling and overlaying the existing asphalt pavement.
- Widening the paved shoulder between 5th Street and Meadow Valley Drive from 3 feet to 5 feet on either side.
- Narrowing the roadway 4 feet on either side for a total of 8 feet with new curb and gutter and in-kind storm sewer replacements between 3rd Street and Cameron Avenue.
- Extending the existing sidewalk on the north and south sides of WIS 186 between Wisconsin Street and Robert Street where none currently exists.
- Replacing existing curb ramps to meet standards between Robert Street and Oak Street.
- Replacing curb and gutter in spots as needed within the project limits.
- Replacing guardrail in the northwest quadrant and placing new guardrail in the northeast quadrant of the bridge over Hemlock Creek.
- Replacing existing culverts approximately 200 feet south of 3rd Street.

<u>Project ID 6620-00-01 (71)/6620-00-02 (72)—Oak Street to US 10/WIS 73 to 5th Street:</u> The total project length for these sections of WIS 186 are 11.4 miles (ID 71) and 2 miles (ID 72). The proposed improvements include:

- Milling and overlaying the existing asphalt pavement.
- Paving the entire 6-foot shoulder width from Oak Street to US 10.
- Widening the paved shoulder between Well Road and 5th Street from 3 feet to 5 feet on either side.
- Replacing guardrail at the structures across Mill Creek and the North Branch of Mill Creek.
- Replacing existing culverts.

Proposed traffic impacts

During construction on WIS 186, the roadway would be closed to through traffic, and a posted detour would be provided. Access to local residents and emergency vehicles would be maintained at all times.

Construction for all three projects is currently scheduled for 2028.

Real estate

Permanent right of way and temporary limited easements (TLE) for curb ramp updates are anticipated. TLEs are also anticipated at guardrail and pipe replacement locations. WisDOT expects to begin real estate acquisition in summer 2026.
