Purpose

The intent of this meeting is to provide information regarding proposed Wisconsin Department of Transportation (WisDOT) improvement project along WIS 22 and 47/55 in the city of Shawano. Each meeting will begin with a short presentation followed by open house format for questions. All attendees are encouraged to ask questions and provide comments on the improvement project. Our objective is to obtain your input on the identified needs, proposed improvements and real estate needs along WIS 22 and 47/55.

Project Information

We are proposing to improve 1.0-mile of WIS 22 (Main St) from Zingler Avenue to Green Bay Street and 0.26-miles of WIS 47/55 (Main St) from Green Bay Street to the bridge over the Shawano Lake Outlet Channel.

The purpose of the proposed project is to improve the pavement and safety of Main St. between Zingler Avenue and the Shawano Lake Outlet Channel, in the city of Shawano.

The project needs can be divided into the following components:

- Replace deteriorating pavement
- Upgrade or replace traffic signals
- Replace non-compliant pedestrian curb ramps

Proposed improvements include:

- Remove and replace asphalt pavement within the travel lanes of Main Street and adjoining intersections.
- Milling and resurface the existing parking/shoulder lanes
- Update traffic signals at Leig Avenue
- Replace traffic signals at Division Street and Green Bay Street
- Reconstruct pedestrian curb ramps that do not meet ADA compliance
- Spot curb and gutter repairs


Project staff are in the process of evaluating the impacts to any historical and archeological property sites. The environmental documents will be drafted in the next few months.

Proposed traffic impacts

This project is utilizing several different staging methods to balance the following: traffic impacts, safety, overall schedule, pedestrian accommodations, access to property owners and business impacts.



Anticipated Timeframes:

Stage 1 8 -10 Weeks*

Stage 2A 2 - 4 Weeks*

Stage 2B 2 - 4 Weeks*

Stage 3A 2 - 4 Weeks*

Stage 3B 2 - 4 Weeks*

* Weather Dependent.

Estimated Project Timeline

May - October**

** Subject to Weather and contractor scheduling

Stage 1:

Stage 1 proposes to close Main Street from Zingler Avenue to Green Bay Street. Lieg Avenue and Division Street crossing will be staged and remain open to east-west crossing traffic, at times on a gravel surface. All remaining sideroads will be closed to through traffic, but open to private residents or businesses within the project limits. Lane closures on Green Bay Street and Division Street will occur but not at the same time.

Stage 2A & 2B:

Stage 2A proposes to close the parking lanes between Green Bay Street and 4th Street and shift both through traffic lanes to one half of Main Street. In 2B, traffic will then be shifted to the new pavement and construction will continue on the 2nd half of the street.

Stage 3A & 3B:

Stage 3A proposes to close the parking lanes and reduce WIS 47/55 to one (1) lane and shift traffic to one half of Main Street between 4th Street and the bridge over the Shawano Lake Outlet Channel. In 3B, traffic will then be shifted to the new pavement and construction will continue on the 2nd half of the street. Temporary traffic signals will be utilized to maintain the single lane of traffic on this segment of Main Street.

Detour Information

During stage 1, WIS 22 is anticipated to be detoured during construction. The proposed detour route will be WIS 29 to WIS 47/55.



Access to local residents, businesses and emergency responders within the road closure will be maintained. The contractor will notify property owners before any short interruptions to access occur.

Real estate

Right-of-way (ROW) impacts are anticipated at pedestrian curb ramp reconstruction areas (intersection corners). Pedestrian curb ramps were designed within the existing ROW to the extent possible, but minor ROW acquisition and temporary limited easements are anticipated at the majority of the new curb ramps.

WisDOT expects real estate coordination to begin in the winter of 2025-2026.
