Purpose

The public outreach is being conducted to inform the general public and local officials, in regard to the upcoming improvement project on WIS 23, from the Adams County Line to I-39, located in the town of Douglas and the town of Moundville in Marquette County.

A Local Officials Meeting was held on March 31, 2025, to allow for officials to provide feedback on the project.

No public involvement meeting is being held for the project. All persons interested in the WIS 23 project are encouraged to view the attached materials.

Project Information

The purpose of this project is to improve the existing pavement and enhance the roadway width, which has significantly deteriorated and is marked by numerous cracks, ruts and previous spot repairs. This project aims to restore the pavement's performance, extend its service life and provide a safer driving experience for all users. There is a need to address the deteriorating condition of the existing pavement, which exhibits significant distress, including low-level alligator cracking, longitudinal and transverse cracking, and faulting. These issues not only compromise the pavement's performance but also pose safety risks to drivers and other roadway users. Additionally, the presence of ruts and prior spot repairs highlights a decline in the pavement's overall integrity. If left unaddressed, these conditions are expected to worsen, resulting in increased maintenance costs and heightened safety concerns. Furthermore, inadequate shoulder width and drainage issues contribute to unsafe driving conditions, making timely intervention essential.

The 8.48-mile project along WIS 23 from the Adams County Line to I-39 involves milling and overlaying the existing pavement to extend its service life. The 12-foot driving lanes will be maintained, with shoulders remaining as 3-foot paved and 2-foot aggregate. To improve safety for cyclists and pedestrians, the paved shoulder between the Adams County Line and Cemetery Road will be widened from 3 feet to 5 feet, reducing the gravel portion without increasing the overall shoulder width.


Several culverts will be replaced and a non-functional cattle pass will be replaced. The guardrail along the route is in fair to poor condition and will be replaced. The guardrail will be updated to MGS guardrail to meet current standards. Spot repairs will also be made to the curb and gutter at the County A and County P intersections.

To address safety concerns, High Friction Surface Treatment (HFST) will be applied to two curves with known crash patterns, one west of County AA and one at the County X intersection.

The project is currently in the Environmental Document stage of the design process. The environmental document is estimated to be completed in the fall of 2025.


PROJECT SEGMENT LOCATION MAP



PROPOSED PROJECT ACTION AND TYPICAL SECTIONS


ADAMS COUNTY LINE TO CEMETERY ROAD
