Project Location

 Proposed improvements extend from WIS 66 to WIS 29







Project Need (Roadway)

- Pavement deficiencies
 - Longitudinal cracking
 - Transverse cracking
 - Rutting
 - Edge and alligator cracking
- Safety
 - Outdated guardrail
- Drainage
 - Corroded cross culverts



















Project Need (Structures)

- Three existing bridges show signs of deterioration including:
 - Deteriorated concrete deck
 - Outdated bridge railings
 - Deteriorated edge of deck
 - Corrosion on steel girders







Project Need (Structures)


- Bradley Creek
 - Existing culvert is undersized
 - New box culvert will be added to better match existing stream channel








- WIS 66 to WIS 29
 - Remove top 2.5" of asphalt pavement
 - Repave with 2.5" of new asphalt pavement
 - Replace deteriorated cross culverts








- WIS 49 over Holt Creek (B-49-527)
 - Concrete overlay
 - Repair deck edge
 - Repaint steel girders








- WIS 49 over Little Wolf River (B-37-428)
 - Concrete overlay
 - Wingwall repair







- WIS 49 over Little Wolf River (B-37-429)
 - Concrete overlay
 - Repair deck edge
 - Spot painting of girders







Construction Timeline


- WIS 66 to County C
 - Roadway and structure work
 - Currently scheduled for 2030
 - Could be constructed as early as 2027
 - Anticipate 3-month construction project
- County C to WIS 29
 - Roadway work
 - Currently scheduled for 2027
 - Anticipate 3-month construction project





Proposed Detour

- Due to scope of work, WIS 49 will need to be closed to through traffic during construction
- Access to local residences and businesses will be maintained
- Detour route proposed:
 WIS 66, I-39, WIS 29







Real Estate

- Right of way acquisition is anticipated
 - FEE (permanent right of way)
 - TLE (temporary limited easements)
- Right of way acquisition may be needed for cross culverts, intersections, and areas where additional grading is required
- Acquisition to begin in the winter of 2025-2026
