

#### **Purpose**

The purpose of this outreach is to gather public input regarding the proposed improvements and traffic management strategies during construction of the WIS 49 project. Construction ID 6270-00-77 will resurface WIS 49 from Cedar Road to Lake View Road, and Construction ID 6270-00-78 will resurface WIS 49 from Lake View Road to WIS 66.

#### **Project Information**

Improvements are proposed along 2.69 miles of WIS 49.



The purpose of the proposed project is to preserve the function, operation, and safety of WIS 49 from Cedar Road to WIS 66.

The project is needed to address the deteriorating pavement conditions and deficient drainage facilities along WIS 49. The existing asphalt surface in this section of WIS 49 is exhibiting signs of deterioration in the form of low-level longitudinal cracking, transverse cracking, and alligator cracking. Several culverts along the corridor are showing signs of corrosion, damage and sedimentation.

Proposed improvements include:

- 6270-00-77, Cedar Road to Lake View Road
  - Resurfacing the existing pavement by milling 4-inches and overlaying with 4-inches of new asphalt pavement
  - Widening paved shoulders to 3-feet
  - Replacing deteriorated culvert pipes

- Cleaning blocked culvert pipes
- Spot grading of ditches to improve drainage
- Repainting pavement markings
- 6270-00-78, Lake View Road to WIS 66
  - Resurfacing the existing pavement by milling 2.5-inches and overlaying with
     3.5-inches of new asphalt pavement
  - Widening paved shoulders to 3-feet
  - Replacing or lining deteriorated culvert pipes
  - o Replacing pavement at WIS 66 intersection
  - Repainting pavement markings

Environmental studies and historical/archaeological surveys are underway.

# **Proposed traffic impacts**

Construction is currently scheduled to begin in 2028, but could occur as early as 2027.

During construction, the roadway will be open to traffic using flagging operations to perform the work.
