Purpose

The DOT is seeking public comment and input for a proposed project on WIS 64 between Merrill in Lincoln County to Antigo in Langlade County. Due to the straightforward nature of the project, the public involvement process will consist only of a public comment period, running from Jan. 12-27, 2025.

Project Information

WisDOT is proposing to improve 3.5 miles of WIS 64, from approximately Zima Road west of the city of Antigo to US 45 in the city.

The purpose of this project is to address the deteriorated condition of WIS. The current pavement along WIS 64 is exhibiting signs of distress in the form of longitudinal and transverse cracking and rutting. If you have any input, comments or any other relevant information, please submit a comment form so that we can consider them as part of this project.

Proposed improvements include:

- Milling 3.75 inches of existing asphalt pavement
- Paving 3.75 inches of asphalt pavement
- Making minor shoulder improvements
- Completing pavement marking

This project primarily seeks to address the cracking, rutting and the overall deterioration of the roadway. The proposed project will not change the current layout of the roadway; however, milling off the top layer of the existing asphalt and replacing it with new asphalt will extend the service life of the roadway in a cost-effective manner and provide motorists with a smoother ride.

An environmental study is underway for the project, but due to the limited scope of the project, the study is not expected to have a significant impact on project outcomes.

Proposed traffic impacts

Construction is currently scheduled for 2029, with work beginning in spring/summer and ending by that fall.

During construction, WIS 64 will be open to traffic between Zima Road and US 45; however, motorists can expect to encounter lane closures controlled by flagging operations. Access to homes and businesses in the work zone will be maintained throughout the construction process, but there might be minor delays as the milling machine or asphalt paver passes.

No real estate acquisition is included in this project.
