Thov tuaj koom nrog peb rau qhov kev sib tham rau pej xeem los tham txog kev npaj txhim kho cov chaw nce thiab nqis txoj kev (curb ramp) ntawm US 10 / WIS 66 ntawm County C thiab Badger Avenue, uas nyob hauv lub nroog Stevens Point thiab lub zos Park Ridge hauv Portage County.

Lub rooj sib tham tau teem rau hnub Wednesday, Lub Xya Hli 16, 2025, thaum 5 txog 7 teev tsaus ntuj, ntawm Portage County Annex Building, 1462 Strong Ave, Stevens Point, WI 54481. Lub rooj sib tham yuav yog hom qhib tsev.

Muaj ib txoj haujlwm thoob lub xeev uas npaj yuav hloov kho cov chaw nce thiab nqis txoj kev (curb ramps) ntawm cov kev loj uas muaj nyob rau hauv lub xeev kom raws li cov qauv qhia los ntawm Americans with Disabilities Act (ADA). Qhov haujlwm no tsim nyog ua vim tias feem coob ntawm cov curb ramps uas nyob hauv thaj tsam uas npaj yuav kho no tam sim no tsis raws li cov qauv ADA. Cov curb ramps uas muaj nyob hauv qhov haujlwm no yuav raug hloov kho kom raws li ADA tus qauv ua tau raws li qhov yuav ua tau. Qhov no yuav pab tshem tawm lossis txa qis cov teeb meem thiab cov teeb tsa uas cuam tshuam rau cov neeg uas taug kev. Kev tsim kho tam sim no npaj tias yuav pib xyoo 2027.

Pcov neeg ua haujlwm tsim kho thiab cov neeg sawv cev vaj tsev yuav muaj nyob rau ntawm qhov no kev sib tham los teb cov lus nug thiab muab kev pabcuam notary. Lub hom phiaj ntawm qhov kev sib tham yog:

1. Teb cov lus nug koj yuav muaj txog lub phiaj xwm.
2. Rau cov tswv cuab vaj tse uas muaj kev cuam tshuam txog vaj tse:
 - a. Teb cov lus nug tshwj xeeb txog qhov project, thiab cov kev cuam tshuam rau koj lub cuab yeej.
 - b. Los sib tham txog qhov kev thov xa rau koj cais thiab muab sijhawm rau koj kos npe rau cov ntaub ntawm hauv pob ntawv kev thov nrog ib tug Notary Public.

Yog tias koj tau txais ib pob ntawv muaj kev pom zoo, thov nqa cov ntaub ntawv mus rau lub rooj sib tham. Tag nrho cov tswv cuab yuav tsum kos npe. Yog tias koj muaj txij nkawm, ob leeg yuav tsum kos npe. Cov neeg sawv cev vaj tsev yuav nyob ntawd los pab teb cov lus nug lossis kev txhawj xeeb thiab pab ua ntawv pov thawj.

Peb tos ntsoov yuav sib ntsib nrog koj. Lub chaw sib tham muaj kev nkag tau rau lub rooj log. Cov neeg lag ntseg, hniv tsis zoo, dig muag-lag ntseg, thiab muaj teeb meem hais lus yuav tsum hu rau Wisconsin Relay Service los ntawm kev hu 711.Txhawm rau muab sijhawm npaj rau kev pab uas xav tau kom tuaj koom, thov hu kuv tsis lig dua peb hnub ua haujlwm hnub ua ntej rau lub kev sib tham.
