

## Purpose of study

WIS 32 / Ashland Avenue is a major arterial that connects I-41 and Ashwaubenon to downtown Green Bay. The Wisconsin Department of Transportation (WisDOT) is in the process of studying possible improvements to the roadway and structures on WIS 32 / Ashland Avenue in Brown County. This study will evaluate options to address the condition of the roadway and structures between 9th Street and WIS 54/Mason Street, which includes the 730-foot-long steel girder bridge over 6th Street and the vacant Canadian National rail yard and the 114-foot-long slab span structure over 5th Street.

## **Public input/comments**

Your comments assist us in developing a project that will serve the needs of the traveling public as well as the needs of the local community and are welcomed and appreciated throughout the design process. ## Study location

The study area encompasses approximately 0.6 miles of Wisconsin Highway 32 / Ashland Avenue from Wis 54 / Mason Street to 9<sup>th</sup> Street in the City of Green Bay, Brown County.

## Study purpose and need

The purpose of the study is to address the condition of the WIS 32 / Ashland Avenue roadway, the bridge spanning over the Canadian National Railroad rail yard and 5th Street roadway, and the adjacent retaining walls.

The project needs are anticipated to be the following:

- Bridge condition
- Safety conditions
- Bicycle and pedestrian accommodations

Proposed concepts to be studied are:

- No build
- At-grade alternative

- Bridge replacement with identical span and geometry
- Refined span and geometry

## **Possible improvements**

Depending on the alternative selected, the proposed improvements may include:

- New roadway
- New bridge and structures
- New street grid connecting adjacent neighborhoods
- New pedestrian and bicycle accommodations

The study phase of the project will complete the required National Environmental Policy Act (NEPA) document and identify a preferred alternative that will move forward in design and construction.

## **Traffic impacts**

Traffic impacts will not be known until the study concludes and a project is initiated.

## Schedule

#### Current

 Ongoing coordination with local units of government, stakeholder groups, and gathering of public feedback and comments.

# Next Public Meeting

 Winter of 2025/2026 – WisDOT will refine study alternatives and based on concepts under review and public feedback. In Winter 2025/26, the study team will hold another public involvement meeting with more defined improvement concepts to share with the public.

#### Future

- o Study Phase 2024-2026
- o Preliminary Design 2027
- o Real Estate, Utilities and Final Design 2028-2030
- o Construction currently scheduled in 2031
  - Could be advanced to end of 2030

## Real estate

WisDOT will try and minimize impacts to properties whenever possible. Potential right-of-way impacts for alternatives will be identified as the study progresses. If private property is affected, a member of the WisDOT real estate team will contact affected property owners.
