#### Purpose of handout


The Wisconsin Department of Transportation (WisDOT) is in the process of developing plans for proposed improvements on 2.9 miles of WIS 42 in the city of Manitowoc, Manitowoc County. The purpose of this handout is to provide information regarding the proposed improvements, describe the potential impacts it would have on the community, and offer an opportunity for public comment.

#### **Public input/comments**

Your comments assist us in developing a project that will serve the needs of the traveling public as well as the needs of the local community and are welcomed and appreciated throughout the design process. Included at the end of this handout, as well as on the project website, is a comment form that may be used for written comments regarding the proposed improvements. You are encouraged to fill out this form and return using the pre-paid mailer attached. Comments may also be submitted via email or phone to the contact listed at the end of this handout.

#### **Project location**

WIS 42 from just east of the County "R" (South Rapids Road) intersection to just west of the South 8<sup>th</sup> Street intersection. The on and off-ramps at the I-43 interchange will also be included.



#### Project purpose and need

The primary purposes of the project are to improve the deteriorating pavement surface and extend the service life of WIS 42, to improve safety at the intersections along WIS 42, and to upgrade other roadway deficiencies.

Currently, the existing pavement is showing signs of deterioration including longitudinal and transverse cracking in the concrete and asphalt pavement. The pavement surface has reached the end of its useful life and should be replaced.

The following intersections have been identified as candidates for improvement due to having high crash rates and/or operational deficiencies:

- Dewey Street
- Grand Avenue
- 39<sup>th</sup> Street
- 36<sup>th</sup> Street
- 30th Street
- Custer Street

#### **Anticipated benefits**

The project will provide motorists with a smoother riding surface resulting in less wear on vehicles, extending the life of pavement, decreasing maintenance costs, and improving the operations and safety at intersections. The project will also provide pedestrian and bicycle accommodations and improved curb ramps to meet ADA standards.

#### **Proposed improvements**

This is a preliminary design-level project. Proposed improvements include:

- Replace the existing pavement structure and curb and gutter with new concrete pavement and curb and gutter
- Replace the existing sidewalk and improve curb ramps to meet ADA standards
- Intersection reconfigurations at the Dewey Street, Grand Avenue, 39<sup>th</sup> Street, 36th Street, and 30<sup>th</sup> Street intersections
- Replacement of all traffic signals
- Round-a-bout at Custer Street
- Conversion of the 4-lane roadway from 26<sup>th</sup> Street to 8th Street to a two-lane roadway with a Two-Way Left-Turn Lane (TWLTL), bike lanes, and on-street parking.
- Replace I-43 interchange ramp pavement with new concrete pavement
- Replacement of water main, sanitary sewer, and storm sewer
- Pavement marking

#### Traffic impacts

WIS 42 plans are still being developed. Possible traffic impacts include lane closures, traffic staging, and detours.

Environmental Document: Summer 2024

• PIM #2: 2025

Project design: 2023-2028

Final Design: 2028

Construction currently scheduled in 2029 and 2030

#### Real estate

Permanent right-of-way (FEE) and Temporary Limited Easements (TLE) would be required for improvements along the project corridor. A second public involvement meeting will be held to discuss detailed intersection designs and impacts. A member of the Department's real estate team will contact affected property owners.
