Project location and limits

This is a resurface level improvement of US 45 between Scott Street and Lone Elm Road. The project is in the village of North Fond du Lac and the town of Friendship.

Project need

The purpose of this highway improvement project along US 45 between Fond du Lac and the north county line is to improve pavement conditions and address deficiencies in the existing corridor.

Proposed improvements

This is a 7.478-mile resurface level improvement of US 45. The project will consist of milling existing pavement and overlaying asphaltic pavement, replacing beam guard and regrading around new beam guard to current standards, and replacing 5 cross culverts under US 45.

Traffic control during construction

Traffic on US 45 at the project location will be maintained during construction. The project will be constructed under rolling lane closure. Access to businesses and residences will be maintained throughout construction. However vehicular access may be limited during specific construction activities, but this will be coordinated between the construction engineer and the business owner or resident.

Right of way needs

Right of way acquisitions are not anticipated as part of this project.

Schedule

The project is anticipated to start construction in summer of 2024 and will be completed in 2024.
