Purpose of handout

The Wisconsin Department of Transportation (WisDOT) is in the process of developing plans for proposed improvements at the two WIS 47 and County A intersections in Outagamie County. The purpose of this handout is to provide information regarding the proposed improvements, describe the potential impacts it would have on the community, and offer an opportunity for public comment.

Project location

The two intersections of WIS 47 and County Highway A are located between Appleton and Black Creek in the towns of Center and Black Creek, Outagamie County. The following map shows the approximate project limits.



Project purpose and need

The purpose of the proposed action is to improve safety at the two intersections of WIS 47 and County Highway A while providing acceptable traffic operations.

Proposed improvements

This is a reconstruction-level project. Proposed improvements include two, single lane roundabouts. The dedicated southbound lane to County A south would be eliminated.

Project includes:

- Two, new single lane roundabouts
- New pavement structure
- New pavement marking and signing
- New culvert and/or storm sewer installation
- Intersection lighting

Anticipated benefits of the project

- Improved safety at the intersection.
- Decrease speeds through the intersections.
- Eliminate right angle crashes within the intersections.
- Predicted to reduce the number of severe crashes at the intersections.

Traffic impacts

The WIS 47 and County Highway A intersections will be closed during construction and detour routes would be posted. The tentative detour route includes County S, County PP, and County B for WIS 47 traffic. Local access to property owners and businesses within project limits will be maintained throughout the project.

Schedule

- Virtual Public Involvement meeting: December 10, 2024
- Environmental Document: Fall 2025
- Real estate acquisition is anticipated to begin in 2027
- Design is on-going and will continue through spring of 2028
- Construction is tentatively scheduled for 2029

Real estate

Right of way acquisition in the form of Permanent (FEE) and Temporary Limited Easements (TLE) are anticipated for the construction of the selected alternative.
