This letter is intended to provide notification of an upcoming Wisconsin Department of Transportation (WisDOT) rehabilitation project in the Northwest Region. Any comments received will be documented in the environmental review process. The WisDOT project team appreciates your participation and comments on this preferred alternative.

Project Description

The proposed project consists of applying polymer overlays to ten structures to extend the lives of the bridge decks. Construction is currently scheduled for the summer of 2028.
