### **Purpose**


The Wisconsin Department of Transportation (WisDOT) is in the process of developing plans for proposed improvements on approximately nine miles of I-94 in Jackson and Monroe County. The purpose of this handout is to provide information regarding the proposed improvements, describe the potential impacts and offer an opportunity for public comment.

Your comments assist us in developing a project that will serve the needs of the traveling public as well as the needs of the local community and are welcomed and appreciated throughout the design process.

Included at the end of this handout, as well as on the project website, is a comment form that may be used for written comments regarding the proposed improvements. # **Project location**

The project is located on I-94 beginning at County O in the Jackson County town of Millston and continues into the towns of Grant and Lincoln and village of Warrens in Monroe County, ending at County EW.



# Project purpose and need

I-94 was originally constructed with new concrete pavement in 1968. In 1981, new concrete pavement was constructed on top of existing pavement. Pavement repairs occurred in 1991 and 2008. Asphaltic overlays were placed in 2009 and 2016.

The roadway is currently exhibiting signs of deterioration in the form of alligator, longitudinal and transverse cracking. Overlays of the existing pavement are no longer feasible due to steepening of the side slopes. The pavement is approaching the end of its service life.

There are other needs that have been identified throughout the project area:

- Deteriorated drainage culverts
- Roadside drainage ditches are filled with sediment
- Deteriorated and outdated guardrail that does not meet current safety standards
- Deteriorated right-of-way fencing along westbound I-94
- Ongoing deterioration on the eastbound and westbound I-94 bridges over County O (concrete pier damage and deterioration of paint on steel girders)
- Ongoing deterioration on the bridge decks on the westbound I-94 bridges over UP RR, Aspen Avenue and County EW







# **Proposed improvements**

To address the project needs, work would include full depth pavement replacement on westbound I-94 and at the County O and County EW interchanges with pavement improvements planned on the westbound ramps and the local roads between the ramp terminals.

Other improvements include:

- Replacing select culverts and completing repairs/cleaning where required
- Adding riprap (stone to prevent erosion) at outlet of C-27-50 at Rudd Creek
- Replacing guardrail
- Replacing the right-of-way fence along westbound I-94
  - Including measures to address safe wildlife movement in cooperation with the Wisconsin Department of Natural Resources
  - o Increasing the height to help minimize wildlife migration into the highway right of way
  - Lowering height locations to promote wildlife to leave the highway right of way
- Installing ramp gates that will allow closure of ramps in an emergency at County EW entrance ramps
- Replacing select signing and installing new pavement markings
- Repairing the following bridges to extend their service life:
  - Completing concrete pier repairs and painting the girders on east- and westbound bridges (B-27-59/60) over County O
  - Completing polymer overlays on the westbound bridges B-41-63, 65 and 67 over the UP railroad tracks, Aspen Avenue and County EW

## **Proposed traffic impacts**

#### Construction is currently scheduled to begin in 2027.

- Work is planned to occur from fall 2027 through spring 2030.
- Construction could begin as early fall 2026 dependent on funding.

#### Staging plans will minimize impacts to peak traffic periods.

- I-94 cannot have long-term lane closures after Memorial Day.
- Work will not occur at the County O and County EW interchanges at the same time.
- Other local roads will offer motorists additional options for navigating around the work zone.

#### I-94 Traffic

 I-94 will remain open to traffic under bidirectional traffic – one lane in each direction -- along eastbound I-94.

#### Ramp closures

- Close of westbound ramps at County O and County EW during interchange work
- Post ramp detours during closures
- County O and County EW ramps will not be closed at the same time.

#### County O

- Complete County O pavement reconstruction with one-lane signalized traffic conditions
- Post a detour for vehicles as a short-term closure will be required for some paving operations
- Maintain ATV traffic under I-94 always

#### County EW

Close and detour County EW during pavement reconstruction

#### Proposed stages (subject to favorable weather conditions)

- Stage 1 -- Fall 2027: Temporary work on I-94 with single-lane closures
- Stage 2 -- Spring 2028: Construct I-94 in Jackson County under bidirectional traffic conditions
- Stage 3 -- Summer/fall 2028: Complete County O interchange
- Stage 4 -- Spring 2029: Construct I-94 in Monroe County under bidirectional traffic conditions
- Stage 5 -- Summer/fall 2029: Temporary work on I-94 with single-lane closures
- Stage 6 -- Spring 2030: Complete County EW interchange

#### Real estate

Work is anticipated to occur within the existing right of way. New right-of-way fence will be placed inside the existing right of way. If the fencing helps to contain livestock, please contact WisDOT so that we can coordinate with you during replacement of the fence.

# **Project schedule**

- Data collection 2022
- Concept plan development and agency coordination 2023-24
- Local official meeting Sept. 16, 2024
- Public involvement comment period Sept. 23 to Oct. 18, 2024
- Environmental document Winter 2024
- Preliminary plans Spring 2025
- Final plans Feb. 1, 2026 (early)
- Business coordination meeting Spring 2028 (if required)
- Construction Fall 2027 through spring 2030\*\*
  - \*\* Construction could begin as early as fall 2026 if funding becomes available.

Additional local and public meetings will be held if necessary.
