### **Purpose**

The Wisconsin Department of Transportation (WisDOT) is in the process of developing plans for the proposed pavement improvements along 7.5 miles of US 10 from Bachelors Avenue to WIS 73 South.

The purpose of this handout is to provide information regarding the proposed improvements, describe the potential impacts and offer an opportunity for public comments.

Your comments assist us in developing a project that will serve the needs of the traveling public as well as the needs of the local community and are welcomed and appreciated throughout the design process.

### **Project location**

The project is in the towns of Hewett and Pine Valley and city of Neillsville.

### Project purpose and need

The existing pavement was last maintained in 2010 with an overlay. The existing pavement is deteriorating with cracking and rutting throughout. Additional needs include:

- Sinking section of pavement (300 feet) located about 1,000 feet west of Sidney Avenue west of Neillsville
- Run-off-the-road crashes
- Deteriorating culverts
- Deteriorating curb and gutter, inlets and guardrail
- Existing curb ramps do not meet Americans With Disabilities Act (ADA) standards
- Deteriorating components of bridge B-10-99 over Wedges Creek and bridge B-10-131 over the Black River

### **Proposed improvements**

The proposed improvements would include:

- Resurfacing asphaltic pavement
  - This work includes recycling of a portion of the existing pavement and overlaying with new asphaltic pavement.
- Paving 5-foot shoulders and adding shoulder rumble strips to reduce run-off-the-road crashes
  - Three feet of the existing shoulders currently paved.
  - Shoulder paving is proposed from Bachelors Avenue to 2,000 feet west of WIS
     73 South (55 mph speed zone).
- Replacing approximately 300 feet of pavement located about 1,000 feet west of Sidney Avenue to address the ongoing settlement
- Replacing, repairing or cleaning culverts (approximately 30 culverts)
- Repairing spot locations of curb, gutter and inlets
- Replacing guardrail
- Upgrading curb ramp to meet ADA standards (four)
- Rehabilitating structure B-10-99 over Wedges Creek
- Rehabilitating structure B-10-131 over Black River
- Installing new pavement marking and centerline rumble strips

### Proposed traffic impacts

Construction is currently scheduled for 2029 but could be advanced to 2027, pending funding.

- US 10 will remain open to traffic with single-lane conditions and flagging.
- Local and emergency access will be maintained to adjacent properties.
- Pedestrian traffic will be maintained during construction.
- The project is anticipated to take four to five months to construct.
- All work is dependent upon favorable weather conditions.

A truck detour will be in place during the paving work using US 12 to WIS 95 to WIS 73. A detour is required for trucks to avoid damage to the pavement during resurfacing work. Local traffic and normal vehicular traffic may continue to use US 10 throughout construction.

### Real estate

Truck Detour Route

The project will require new land interests to accommodate culvert repairs and curb ramp replacements. This will include areas of new minor right-of-way (fee) and temporary (temporary limited easement) land acquisitions.

WisDOT expects to begin real estate acquisition in summer 2025. Direct mailings and coordination will occur with impacted property owners. A landowner rights brochure is available for review on the project website.
