### **Purpose**

The Wisconsin Department of Transportation (WisDOT) is in the process of developing plans for proposed improvements along US 2 in Douglas County. The purpose of this handout is to provide information regarding the proposed improvements, describe the potential impacts it would have on the community and offer an opportunity for public comment.

### **Project Information**

We are proposing to improve approximately five miles of US 2 in Douglas County. The US 2 project extends from US 53 South in the town of Amnicon to County D in the village of Poplar.



### We have identified several needs, including:

- Deteriorating asphalt pavement with a segment of settled and heaved pavement between County U and Wentworth Road
- Deteriorated and outdated guardrail that does not meet current design standards
- Deteriorated drainage culverts and inlets
- Spot curb and gutter deterioration
- Ongoing erosion on the roadway side slope at one location







### **Proposed improvements include:**

- Resurfacing the asphalt pavement (five miles)
- Repairing two culverts and completing culvert and ditch cleaning at spot locations
- Repairing inlets
- Completing erosion repair at one location on the roadway side slope
- Replacing guardrail at two locations
- Removing driveway for closed borrow site
- Replacing centerline and shoulder rumble strips to maintain safe operating conditions
- Installing new pavement markings

### **Proposed traffic impacts**

Construction is currently scheduled to begin in spring of 2028 but could be completed as early as 2027.

During construction, motorists can expect to encounter daily flagging operations and single-lane closures. The need for a detour to complete paving near US 53 is possible but not anticipated. Motorists can expect some delays to occur during flagging and lane closures, but delays will be managed through limiting contractor operations at critical times.

Access to adjacent properties will be maintained during construction. Brief interruptions in access may occur temporarily at driveways. The contractor will be required to notify homeowners and businesses prior to construction.


Construction is currently scheduled for completion in fall of 2028.

#### Real estate

All work is anticipated to be completed within the existing US 2 right of way. If right-of-way needs are determined, those property owners will be contacted directly.

### Other projects

Projects 1180-00-11 and 1180-05-04 are also located within the project limits. Both other projects are scheduled for construction in 2027 and will replace large culverts under US 2 and the Tri-County Corridor. See the location map below.
