



WIS 13: Price County Line to Morse Road

Ashland County, WI

Fall 2024



To address deteriorating pavement and structures on WIS 13 between Park Falls and Mellen, WisDOT is proposing three projects over two years:

1610-00-01 (71): Price County Line to Morse Road

Project Description

- 🚧 Replace, reset, extend or abandon existing culvert pipes and construct a new box culvert at Becky Creek.
 - ⚠️ Temporary easements will be required for this work.
- 🚧 Make concrete surface repairs at the bridge over Dryden Creek northwest of Glidden, patch the deck on the bridge over the Chippewa River southeast of Glidden and overlay the deck with concrete on the bridge over Butternut Creek south of Butternut.
- 🚧 Replace guardrail at the structures and one other location in the project limits.

Traffic Impacts

- 🚧 Flagging will be used to complete bridge work, temporary signals will be used to control traffic at the box culvert construction site, and lane closures will be used to complete remaining work.

Construction

- 🚧 Construction currently is scheduled for 2026.

1610-01-08 (78): Weeping Willow Lane to East Mack Street

Project Description

- 🚧 Replace the pavement on WIS 13 on the 0.29-mile section in Glidden.
- 🚧 Replace curb, gutter, pavement markings, sidewalk, sidewalk curb ramps, signs and storm sewer.
 - ⚠️ The town of Jacobs also intends to replace sanitary sewer and water utilities.

Traffic Impacts

- 🚧 Lane closures controlled by flagging, along with short-term detour routes, will be used to complete work.

Construction

- 🚧 Construction currently is scheduled for 2027.

1610-01-12 (82): Price County Line to Morse Road

Project Description

- 🚧 Remove two inches of the existing pavement on WIS 13 and side road intersections and place two inches of new asphalt pavement.
- 🚧 Install centerline rumble strips.
- 🚧 Replace pavement markings.

Traffic Impacts

- 🚧 Lane closures controlled by flagging will be used to complete work.

Construction

- 🚧 Construction currently is scheduled for 2027.



Project Schedule

- 🚧 Fall 2024: Hold public involvement meeting and solicit comments.
- 🚧 Summer 2025 and 2026: Complete final project design.
- 🚧 Fall 2025 and 2026: Solicit bids for construction.
- 🚧 Summer 2026 and 2027: Begin construction.
