# WIS 29 County X Bridge (B-09-0314) Chippewa County

Project ID: 1050-00-12/82

### Purpose of the meeting

The purpose of this meeting is to discuss the bridge over WIS 29 that is part of the eastbound WIS 29 exit ramp to County X in the Chippewa County town of Lafayette, provide details about the proposed construction project and obtain public input.

Built in 1966, the existing bridge is nearing the end of its service life and needs to be replaced to maintain safety and mobility for the traveling public.

### **Project information**

WisDOT is proposing to improve 0.424 mile of the County X eastbound ramp. Proposed improvements include:

- Removal and replacement of the existing bridge over WIS 29.
- Replacement of the approach pavement on either side of the bridge.
- Replacement of guardrail on the bridge approaches and in the WIS 29 median.
- Replacement of culvert pipes under the County X eastbound ramp.
- Completion of pavement marking, erosion control and any other necessary incidentals.

### Safety and Overall Benefits:

- The new bridge will provide safe travel movements.
- The project will increase the vertical height of the structure over WIS 29 to meet current requirements.
- New pavement approaches on either side of the bridge will provide a better ride quality.
- Guardrail will be updated to meet current standards (i.e., crash tested, connected to the bridge concrete rail, extended to protect steep slopes not currently protected).
- New culvert pipes will maintain a functioning drainage system.

### **Reasons for Improvements:**


- The existing structure is showing signs of deterioration that can no longer be addressed by routine maintenance projects.
- Existing quardrail on the bridge approaches does not meet current requirements.
- The existing culvert pipe joints are separating creating standing water and soil falling into sections of the pipes.

WisDOT chose these improvements because of the age and existing condition of the site facilities, safety concerns regarding the existing structures if not addressed and increased future costs if not appropriately addressed.

### County X Bridge B-09-0314 Project Location Map




### **Proposed traffic impacts**

Construction is currently scheduled to begin in the spring of 2028 and finish in the fall of 2028. During construction, the County X ramp to westbound WIS 29 will remain open. However, the eastbound WIS 29 exit ramp (Exit 80) and the County X bridge will be closed to traffic. The proposed detour sends eastbound WIS 29 traffic wanting to access County X to the WIS 29/50<sup>th</sup> Avenue/Stillson Road interchange (Exit 81), where motorists take 50<sup>th</sup> Avenue east to County J north to get to County X.

The detour is 1.9 miles in length and is expected to add one minute of additional travel time to the County X/County J intersection.

In addition, critical bridge work is expected to require full freeway closure of WIS 29 during nighttime work operations only. These closures will be used only as needed and kept to a minimum. WIS 29 traffic will be detoured during these operations. The nighttime detour sends:

- Eastbound WIS 29 traffic to the WIS 178/Business WIS 29 interchange (Exit 79) to WIS 178 north to Park Avenue/County J east.
  - The WIS 29 eastbound on-ramp from WIS 178/Business WIS 29 will be closed during this time.
  - The eastbound WIS 29 detour is five miles in length and is expected to add six minutes of additional travel time to the WIS 29 eastbound on-ramp merge from County J.
- Westbound WIS 29 to the County J interchange (Exit 81) to County J north to County X west.
  - The WIS 29 westbound on-ramp from 50<sup>th</sup> Avenue/Stillson Road will be closed during this time.
  - The westbound WIS 29 detour is 2.3 miles in length and is expected to add three minutes of additional travel time to the WIS 29 westbound on-ramp merge from County X.

### County X Bridge B-09-0314 Full Freeway Closure Detour Map

During peak travel times, both lanes of traffic on WIS 29, in both directions, will be open to traffic in the work zone. During nonpeak travel times, one lane of traffic on WIS 29, in both directions, will be open to traffic in the work zone.

Temporary driveway/entrance closures or changes to property access are not required.

Construction is currently scheduled for 2028.
