Purpose of the meeting

Welcome to the public involvement meeting for the WIS 11 rehabilitation project.

The Wisconsin Department of Transportation (WisDOT) is planning improvements to the WIS 11 roadway to address deteriorating pavement conditions and the decrease in ride quality.


Our objectives for today's meeting are to:

- Provide you with the proposed scope of the project.
- Obtain your input on the project and any concerns or information.

The meeting will run from 5:00 p.m. to 7:00 p.m. The meeting will follow an open-house format with displays of the preferred alternative available for viewing.

Project information

We are proposing to improve approximately six miles of WIS 11.



Proposed improvements include:

Project 1320-13-01: Pavement Overlay (WIS 36 to County N)

- Mill 4" and pave 4" asphalt pavement
- Maintenance to drainage structures
- Replace guardrail that doesn't meet current standards
- New signing and pavement marking

Project 1320-13-02: Pavement Replacement (County N to County C)


- 6 ¾" asphalt, 14" base aggregate, 16" 20" subbase
- Replace curb & gutter
- Maintenance to drainage structures
- Replace guardrail that doesn't meet current standards
- New signing and pavement marking

Proposed traffic impacts

Construction is currently scheduled for 2029. If funding becomes available, it could potentially be advanced to 2027 or 2028 construction.

During construction, WIS 11, between WIS 36 and County N, is expected to remain open and be reduced to one lane of traffic in each direction using flagging operations. WIS 11, between County N and County C, will be closed to through traffic and detoured. The contractor will be required to provide local access to residents and businesses.

Temporary driveway closures will be necessary during part of the construction process. WisDOT will contact homeowners and businesses in advance before closing a driveway.



Real estate

Additional right of way will be required for this project. Property acquisition will be needed to regrade ditches and to maintain culverts. Preliminary right of way impacts are shown on the exhibits. WisDOT expects to begin real estate acquisition in 2026.
