Purpose of the meeting

The purpose of the proposed project is to address the deteriorating pavement condition and improve ride quality along WIS 11, as well as to assess multimodal needs and address outdated and deteriorating ancillary infrastructure along the corridor, including traffic signal equipment, guardrail, curb ramps, and drainage facilities.

The project team met with local officials on October 7, 2025, regarding the project.

The format of this meeting is open house style. Exhibits will be presented for review. Comment sheets will be available to share feedback on the proposed improvements. Representatives will be present to discuss the project and answer any questions.

Project information

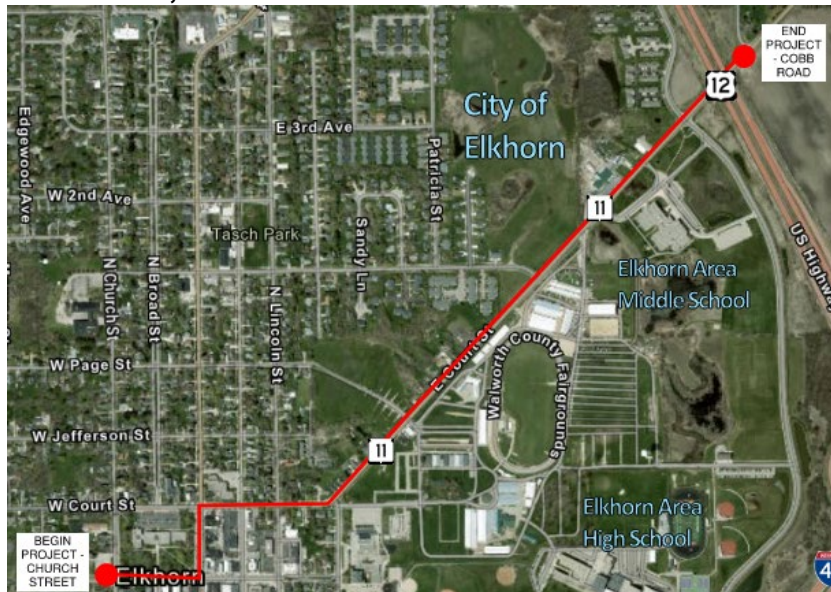
WisDOT is proposing to address the purpose and need of the project by milling 2.25 inches off the existing asphaltic surface and overlaying with 2.25-inches of new Hot Mix Asphalt (HMA). This pavement treatment will extend the service life of WIS 11 and improve ride quality, satisfying the purpose and need of the project.

Additional improvements proposed include:

- Mill and resurface approximately 1.4 miles of the roadway, including pavement repairs.
- Replace traffic signals at Walworth Street and Wisconsin Street, and Wisconsin Street and Court Street intersections.
- Update curb ramps to be ADA compliant.
- Replace and extend sidewalk, curb and gutter and storm sewer near Walworth County Fairgrounds.
- Replace existing guardrail at the US 12 interchange.

The environmental study is currently underway.

WIS 11, CHURCH STREET TO COBB ROAD

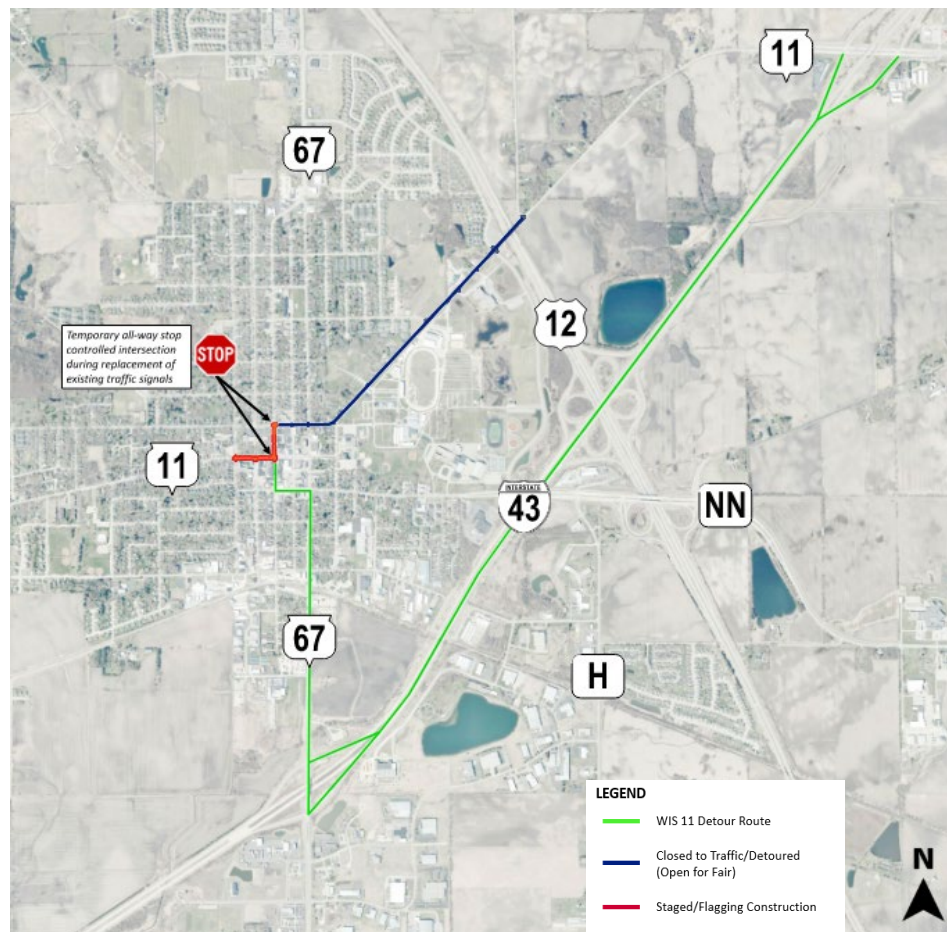


Proposed traffic impacts

Construction is scheduled to begin in 2028.

The design team is still evaluating traffic control and staging for the project. Construction will be completed in several stages. Work on Walworth Street and Wisconsin Street around the Square will be completed with staged construction/flagging and open to traffic. Work on Court St will be completed with a full roadway closure (local traffic only) and detour. The detour route during construction will be WIS 67, I-43, WIS 11.

Access for local traffic and emergency vehicles will be maintained. Lane closures will be communicated closely with local officials and will be restricted during holiday and special event periods. Various intersections may be closed during some stages of construction but access to all properties will be maintained through adjacent intersections.



Real estate

Acquisition of real estate will be required for this project. Most of the work is anticipated to occur within the existing right of way, however real estate acquisition will be required at select locations. No relocations will be required. Temporary Limited Easements (TLE) are needed

throughout the project corridor for construction access, curb ramps and grading. TLE's are similar to temporarily leasing a position of land that ends at the project completion. The land within the TLE's will be restored at the end of construction. There may be some areas where permanent FEE right-of-way may be needed. The City of Elkhorn will reach out to property owners and work with them throughout the design process. Preliminary right of way impacts are shown on the exhibits. WisDOT expects to begin real estate acquisition in 2026.
