Purpose of the meeting

Welcome to the public involvement meeting for the WIS 175 pavement replacement project. The Wisconsin Department of Transportation (WisDOT) is planning to improve 3.5 miles of WIS 175 from Maple Ave to 1600' north of County K in Washington County.

The purpose of this meeting is to provide information regarding the recommended improvements, describe the potential impacts it would have on the community, and offer an opportunity for public comment.

Project information

WisDOT is proposing to improve 3.5 miles of WIS 175. Currently, WIS 175 is a two-lane arterial with posted speeds of 35 mph in the urban sections in Slinger and St. Lawrence and 45 to 55 mph in the remaining rural sections. Land use adjacent to this corridor varies between commercial, residential, and agricultural.

Proposed improvements would include: replacing the deteriorating pavement, curb and gutter, cross culverts, storm sewer and side road ditches to improve drainage, reconstructing existing curb ramps to meet current standards, miscellaneous bridge rehabilitation to extend its service life, and modifying on-street parking near the County K intersection to improve safety.

WIS 175 location map

WIS 175 is located within the village of Slinger and the towns of Hartford, Polk, and Addison in Washington County. The map below shows the approximate project limits.



Proposed traffic impacts

Construction is tentatively scheduled for 2029. WIS 175 and potentially County K will be closed to through traffic during construction with a posted detour route for each road. Local access will be maintained for emergency services and for residents and businesses located within the project limits. Temporary, short-term driveway closures will be necessary during the construction process.

Real estate

Additional right-of-way will be required for this project in the form of permanent (FEE) and temporary easement (TLE). A member of the real estate team will contact affected property owners at the start of the real estate acquisition process. Preliminary right of way impacts are shown on the exhibits.
