Public Involvement Meeting WIS 175 (WIS 60 to N. Maple Ave.)

Purpose of the Meeting

The Wisconsin Department of Transportation (WisDOT) is developing plans for an improvement project on WIS 175 between WIS 60 and N. Maple Avenue in the village of Slinger, Washington County. The purpose of this meeting is to obtain your feedback on the identified needs and proposed improvements. We appreciate your input and encourage you to take a moment to review the project information in this handout and provide comments. Construction is currently scheduled for 2030. (may be advanced to as early as 2028, pending available funding)

The purpose of the project is to address deteriorating pavement conditions and the decreased ride quality along WIS 175 and assess multimodal accommodations throughout the corridor.

Project Information

WisDOT is proposing to improve 1.25 miles of WIS 175. Proposed improvements include:

- Mill 2.5-inch asphalt surface. Pave 2.5-inch hot mix asphalt overlay.
 - Maintain existing roadway footprint.
- Replace existing curb ramps to meet WisDOT and ADA standards.
- Replace curb and gutter in spot locations
- Replace storm sewer in spot locations
- Relocate signal at Kettle Moraine Drive.
- Improve signs to meet WisDOT policy.
- Improve pavement markings:
 - High visibility markings at crosswalks
 - Two new crosswalk locations
 - Slinger Road (Scenic Ave.) / WIS 175 intersection
 - Oak Street / WIS 175 intersection
- Lane reduction reconfiguration on WIS 175 between WIS 60 to Slinger Road (Scenic Ave.)

Proposed Traffic Impacts

During construction, WIS 175 will remain open to traffic. Single lane closures and flagging operations are anticipated. Pedestrians can expect to encounter detours and rerouting.

Driveway access is anticipated to be maintained during the construction process. WisDOT will contact homeowners and businesses in advance if a driveway closure is necessary.

Real Estate

Additional right of way will be required for this project. Preliminary right of way impacts are shown on the exhibits. WisDOT expects to begin real estate acquisition in November 2025.

Project update/next steps

- Final public involvement mailing is anticipated in July 2025.
- Final design is anticipated to be completed by May 2027. The project may be advanced to final design by October 2026.
- Construction is tentatively scheduled to begin in the spring of 2030, with completion in fall 2030. The project may be advanced to construction in 2028, pending available funding.
