Purpose of the meeting

The objective of this meeting is to provide the public an opportunity to provide feedback regarding the project design, an update on the selected design alternative, and obtain feedback on traffic staging along I-43 in Waukesha County.


Project information

The purpose of the project is to replace the existing pavement along approximately 7.46 miles of I-43 between WIS 83 and WIS 164 and reconstruct the I-43 and WIS 164 interchange. The WisDOT selected alternative for this intersection is a new Diverging Diamond Interchange (DDI) layout.

This improvement project will address the deteriorating pavement condition and preserve the condition and extend the service life of the existing bridge decks, address safety and operational needs at the I-43 and WIS 164 interchange, and address drainage needs.

The project need is based on pavement condition, structural maintenance, safety/operational improvements, and drainage improvements.

- The pavement is beginning to deteriorate and experiencing transverse and longitudinal cracking.
 The most recent resurfacing of the project area was completed in 2013 and, at the time this project is scheduled for construction, the pavement will be reaching the end of its service life.
- Crashes, unacceptable delay, and long queues have been identified at the I-43 and WIS 164 interchange on and off-ramps.
- The Big Bend Park and Ride, located at in the southeast quadrant of the I-43 and WIS 164 interchange, needs pavement resurfacing to address weather-related cracking.
- 12 bridges along the corridor need various maintenance repairs performed to extend their service life.
- Drainage issues have been identified along the northbound side of I-43, west of WIS 164, due to poor condition of culverts and drain tile.



Proposed project improvements include:

- Replacing the pavement along I-43 between WIS 83 and WIS 164, including the WIS 83 northbound onramp and southbound off-ramp.
- Reconstructing the I-43 and WIS 164 interchange with the WisDOT selected alternative being a new Diverging Diamond Interchange (DDI) layout to address safety and operational concerns. Traffic signals and lighting at these intersections will be replaced as part of the reconstruction.
- Improvements to the Big Bend Park and Ride, including replacing the pavement with a reduced footprint, replace damaged curb & gutter, and reconstructing curb ramps to be ADA compliant.
- Various maintenance tasks on existing bridge structures

- Replacement of guardrail along the corridor.
- Repair, replace, and/or clean culvert pipes to improve roadway drainage.
- Installation of Freeway Traffic Management System (FTMS) fiber infrastructure
- Replace signage and repaint pavement markings to increase driver visibility.

The Annual Average Daily Traffic (AADT) in 2022 is 41,500 vehicles per day on I-43 between WIS 83 and WIS 164. The proposed project would maintain the current number of lanes.

Traffic impacts

Traffic along I-43 and WIS 164 will be reduced to a single lane in both directions. Work will be staged with a crossover where traffic will be shifted to the opposite direction. It is anticipated that most of the work would occur during daytime hours.

Access for residents, businesses, and emergency services will be coordinated and maintained throughout the project limits during construction.

Environmental Coordination

Environmental studies, including hazardous materials, archaeological and historic review, wetland delineation, threatened/endangered species review, and environmental documentation are ongoing.

Real estate

Minimal real estate acquisition is expected for this project, with impacts occurring around the I-43 and WIS 164 interchange. Work on the I-43 mainline and Big Bend Park and Ride is anticipated to occur within the existing right of way.
